OFFICE ORDER

In continuation to the University Office Order No. 1058 Dated 02-05-2020, Office Order No. 989 Dated 15-04-2020, Office Order No. 980 Dated 09-04-2020, Office Order No. 951 Dated 31-03-2020, Office Order No. 938 Dated 20-03-2020 and Office Order No. 897 Dated 15-03-2020, all the Officers/Officials and staff members of the University & its Constituent/ Affiliated Colleges are informed that as per Punjab Govt. order related to COVID -19, the lockdown is extended further for a period of 2 weeks from 18-05-2020 to 31-05-2020. However, the curfew has not been extended beyond 17-05-2020.

With reference to Punjab Govt. order no. SS/ACSH/2020/424 Dated 17-05-2020, regarding guidelines to be implemented during lockdown 4.0 w.e.f. 18-05-2020 to 31-05-2020, all Deans, Directors, Heads of Departments and incharges of Administrative Branches/ Sections are hereby informed that the offices are allowed to open but teaching shall remain suspended. However, to avoid overcrowding and congestion, minimal required staff should attend office, and remaining staff should work from home. Those attending offices must follow social distancing norms (minimum 6 feet distance for all activities), wear masks compulsorily and follow all Government directives/guidelines, including those issued by Health & Family Welfare Department from time to time.

The non vacational staff and faculty/staff members not on vacation (working from home/ office) must be present in the station of their posting. The incharges of teaching and non-teaching departments must take all necessary precautions while calling the required staff for office work.

All concerned are directed that orders/directions/guidelines of Punjab Government must be followed in true letter and spirit.
