Sub.: Regarding Admission procedure for admissions 2019-20.

Consequent upon the approval by the competent authority vide ref. no. VC/515 dated 18.06.2019, MRSPTU is pleased to announce the following admission procedure for admission 2019-20 in its various affiliated colleges/constituent colleges/ and main campus. The courses have been categorized as- i) AICTE Approved Courses ii) University Approved AICTE courses iii) Non-AICTE or UGC courses, and iv) Skill Certificate Courses.

Such students shall have to produce the receipt of payment at the time of counseling.5. First round of direct counseling shall be executed as per the notified seat matrix in University Information Brochure-2019-20 taking into account seats reservations. However, if seats remain vacant, these can be made open during the spot counseling/reporting.6. Direct Counseling Schedule shall be notified/ advertised by respective colleges themselves on their web-site with intimation to University through the o/o DAA.7. Merit list prepared in each direct round shall be openly displayed to students and kept in records for scrutiny, if desired.8. Vacant seats status after each direct round is to be intimated to University through o/o DAA.9. HoD/Head of the Institute/Authorized nominee of College shall have to submit an undertaking in regards to following all the applicable University/Punjab Govt norms while admitting students.10. For details on admission procedure/eligibility /seat matrix etc please consult University Information Brochure: 2019-20.11. Eligibility norms as notified by Punjab Govt for 2019-20 shall supersede University eligibility norms, wherever applicable.12. Refund rules shall be as per latest AICTE norms.13. Admission should be done only for the seats approved by the AICTE/University for 2019-20. <p>Last date of admission for AICTE courses is 15.8.2019.</p>


