NOTIFICATION

Sub: - Regarding relaxation in Choice Based Credit System 2016

- 1. Choice Based Credit System has been implemented by the university from 2016 batch onwards. As per CBCS 2016 student has to earn minimum 25% of the credits to go to the next year, 50% of the credits of the 1st semester to be eligible for the 5th semester & 50% of the credits of the 1st year to be eligible for the 6th semester.
- 2. Many institutions have requested that due to existing circumstances and ignorance of rule among students, it is difficult to apply this rule as many students have to lose one year due to this rule.
- 3. So with the approval of competent authority this rule is being suspended for the time being. However in the meantime all Principal / Directors of the institution are required to make aware the students about this rule and inform the undersigned every semester the number of students who do not satisfy the conditions of the rule. The rule will be again implemented after these reports of Principals & Directors.

Sub: Syllabus for Bachelor of Pharmacy (B.Pharm) Course- Clause-16-Academic Progression.

Sir,

I am directed to invite your attention to Clause-16-Academic Progression of the syllabus for the Bachelor of Pharmacy (B.Pharm) Course prescribed by the Pharmacy Council of India which provides for the eligibility of students for the promotion to the next year and the carry forward of the courses of various semesters. The syllabus is effective from the academic year 2016-17.

Representations have been received from various universities and the students community as well as the teaching faculty that the implementation of provisions of Clause-16 Academic Progression of the Syallbus for the Bachelor of Pharmacy (B.Pharm) Course has created problems for a number of students this year and requesting for relaxation in promotion guidelines with the carry over papers.

The matter was placed before the 107th Central Council in its meeting held on the 5th & 6th August, 2019 in Chennai which unanimously decided that for the time being, the examining authorities may be permitted to implement the provisions of academic progression under clause 16 of the PCI-Syllabus for the Bachelor of Pharmacy (B.Pharm) Course in line with the existing policy of the university, if different from PCI regulations. However, the universities shall have to align their examination system and academic progression strictly in accordance with the norms prescribed by the Pharmacy Council of India under clause 16 of the PCI-Syllabus for the Bachelor of Pharmacy (B.Pharm) Course within a period of four years and make the students aware of the said norms at the time of admission itself.
