- 2. It was decided to continue the same cash incentives to the eligible sports achievers as approved by Finance committee of the University for session 2017-18.
- 3. It was also decided to organize summer coaching camp during vacations for maximum 50 players at the University campus or in the institutions of university jurisdiction. Diet money including refreshment @150/- per participant per day shall be paid.
- 4. The term daily allowance will be replaced as diet money to overcome technical/financial hindrances regarding payment to the players of host Institute.

- 1. It was decided that a summer coaching camp of 7-15 days may be organized during summer vacation at any hill stations for high altitude training of players. TA, Accommodation charges, meal expenses/diet money and refreshment to the participants, managers and coaches/guides will be paid as per approved rates of Government Regional Mountaineering Centre situated in the region.
- 2. For attendance benefit to the players for participation in sports competitions other than Inter-College and Inter-University, Director Sports & Youth Welfare will be authorized to provide attendance benefits to the players after recommendation of concerned Head & D.P.E.'s as per criteria outlined by Academic Council of MRSPTU, Bathinda.

#### **❖ PART-A:PROCESS FOR HIRING OF ARCHITECT CONSULTANT**

- The proposed expenditure for construction of new buildings of the University was put up in the 1<sup>st</sup> Meeting of Finance Committee held on Dt. 13-08-2015 vide item no. 1.2 (Copy attached at Pg S-11 to 13) in the light of decisions of the 1<sup>st</sup> Meeting of Building Works Committee. Accordingly the proposed building expenditure amounting to Rs. 146 Crores was projected which was approved and this was subsequently approved in the 2<sup>nd</sup> Meeting of BOG held on Dt. 07-09-2015 (Copy attached at Pg S-14 to 15).
- After the approval of expenditure the following process was started:-

### **→** Hiring of Architect Consultant:

The procedure for the same is given below:-

- The RFP for hiring of Architect for the Design/Drawings etc. of the new building was prepared by a Committee of the then Head Civil, Prof. G.S. Bath and Head Architecture, Prof. Bhupinderpal Singh Dhot and Er. Jagdeep Singh Sidhu, SDE after discussion and deliberations with the office of Chief Architect, Punjab from time to time(Copy attached at Pg S-16). This RFP was put up in the 2<sup>nd</sup> Meeting of Building Works Committee of the University held on Dt. 12-10-2015 and was approved with minor amendments (Copy attached at Pg S-17 to 18) Accordingly the changes were made and final RFP was prepared which was uploaded for selection of Architect Consultant by following due process. (Copy attached at Pg S-19 to S-78)
- In the 1<sup>st</sup> Meeting of Tender Finalization Committee held on Dt. 30-07-2015, it was decided that services of Architect should be hired by floating

- e-tender. And according to the requirement of RFP Technical Bid was to be taken by post and Financial Bid to be taken online.(Copy attached at Pg S-79 to S-80)
- The tender for RFP was approved in the 3<sup>rd</sup> Meeting of Tender Finalization Committee held on Dt. 27-10-2015 wherein it was decided that according to the requirement of RFP, It is essential to have the Technical Bid by post and the Financial Bid is to be taken online. (Copy attached at Pg S-81 to S-84). After this approval, the tender was floated on Dt. 11-11-2015 (Copy attached at Pg S-85 to S-86). Whereby the offers were invited in two bid system i.e. Technical Bid and Financial Bid as per the RFP which was uploaded on the website. The Technical Bid was to be obtained offline and Financial Bid was obtained online.
- A Technical Expert Committee for evaluating the RFP was constituted comprising of members a part from the Chief Architect, Head Civil, Head Architect and SDE. (Copy attached at Pg S-87)
- In response to the tender the followings fourfirms made their detailed presentations on Dt. 16-12-2015 (Copy attached at Pg S-88 to S-89)
- 1. M/s Enarch Consultants Pvt. Ltd., Noida.

Ltd., New Delhi and M/s Department of Architecture, GNDU, Amritsar for further refinement of the master plan and the building design. The firms were asked to make fresh presentation of the master plan and the building designs(Copy attached at Pg S-88 to S-89)
- The shortlisted firms made their fresh presentations before the committee on Dt. 05-01-2016. After detailed presentations, clarification and deliberations made, the Technical Expert Committee awarded the scores for the design proposed to the firms based on the criteria detailed in the RFP(Copy attached at Pg S-90 to S-99).
- The Final Evaluation report is attached at Pages S-94 to S-95).

- Based on the above, the contract for the Campus design of Maharaja Ranjit Singh Punjab Technical University, Bathinda was awarded to the Department of Architecture, GNDU, Amritsar (Copy attached at Pg S-100).
- The Appointment of Consultant was approved in the 3<sup>rd</sup> Meeting of the Building Works Committee vide item no. 3.3 held on Dt. 02-04-2016 (Copy attached at Pg S-101 to S-102)and subsequently approved in 4<sup>th</sup>Meeting of BOG held on Dt. 12-04-2016 vide Item no.4.5.(Copy attached at Pg S-103 to S-104).
- The Copy of contract made with architect consultant based on amended RFP is enclosed at Pg S-105 to S-122.

S-227 to S-228) & were uploaded on the tendering website alongwith DNIT by the XEN for Project Supervision/ Management Committee as constituted by the Board and mentioned in the amended RFP.
- ➤ The Technical Bid was opened on dt. 06/09/2016 and was put up before the Technical Evaluation Committee constituted for the purpose (Copy attached at page no.S-229 to S-234) The following firms participated in the E-tender:

- Finally Financial Bids, of the above mentioned 03 No's bidders were opened on dt. 13/09/2016 and the Financial Bid of M/s ASC Builders Pvt. Ltd, Bathinda was lowestat minus 14.58% rates (Copies attached at page no. S-235 to S-238).
- ➤ Vetting of drawings and estimates:- As per Contract agreement of the Consultancy, the drawings were prepared by them & were got vetted from the Consultancy Wing of GZSCCET, Bathinda. Vetting of estimate has been explained in detail above.
- ➤ An amount of Rs. 1.275 Crores has been paid to the Consultancy Wing, GNDU, Amritsar as consultancy charges.
- ➤ An amount of Rs. 5,00,950/- has been received by the Consultancy Wing of GZSCCET, MRSPTU, Bathinda on account of vetting of drawings vide Cheque no. 376208 dt. 19/10/16.

#### **\$** Enhancement/ Escalation:-

Enhancement: -As the work being carried out is expected to cost more than the agreement cost, hence the firm has applied for enhancement vide undertaking dated 15/10/2019(Copy attached at page no. S-239) and is under process. The reasons for increase in cost of the project are detailed below:-

#### • Animal House Building:-

The Building for animal house was not in the original BOQ and was approved in the 5<sup>th</sup> Meeting of BWC held on dt 08-05-2017 vide item no. 5.3 (Copy attached atpage no. S-240toS-242). Funds to tune of Rs. 40 Lacs for same were approved in the 4<sup>th</sup> Meeting of FC held on dt. 26-04-2017 vide item no. 4.3 (Copy attached at page no. S-243 to S-245). The same was approved in BOG in its 6<sup>th</sup> Meeting held on dt. 25-07-2017 vide item no. 6.6 (Copy attached atpage no. S-246 to S-247)

### • Regarding increase in quantity of steel (Item 7.3 of BWC)

This item was taken up in the 7<sup>th</sup> meeting of Building Works Committee held on 12/10/2017. As per clarification sought from the Consultancy Wing, GNDU, Amritsar, they had informed that the qty of steel was taken @ 101.87 kg/cum of concrete, while as per the structural design provided, the factor of steel comes to approximate 162 kg/cum of concrete, due to which there is increase in qty of steel due to which there is increase in cost. (Copy attached at page no. S-248 to S-252)

• It was pointed out by the Consultancy Wing, GNDU, Amritsar that such variation is faced by most of the Govt. departments. Consequently, this item was approved in the 7<sup>th</sup> meeting of Building Works Committeevide item no. 7.3.

### • Regarding size of Kota stone flooring (Item 7.6 of BWC).

This item was also discussed in the 7<sup>th</sup> meeting of Building Works Committee vide item no. 7.6, wherein it was discussed that since the size of slab of kota stone is not mentioned in the CSR. Subsequently, the item was discussed in the presence of Chief Engineer, PWD (B&R), Superintending Engineer, PWD (B&R), the Additional Chief Architect, Punjab and Prof. Karamjit Singh Chahal from GNDU, Amritsar. After detailed discussion and as conveyed by the experts in this matter, the item was approved. These items were also referred to the Office of Advisor (Tech) and the comments are attached whereby the item was to be taken as referred in the DSR (Copy attached at page no. S-256 to S-259)

### • Regarding plaster on underside on ceiling 6mm thick (Item 7.4 of BWC).

This item was discussed in the 7<sup>th</sup> meeting of Building Works Committee. Since, the contractor had expressed his inability to carry on 6mm thick plaster. During discussion, in the presence of Superintending Engineer, PWD (B&R), Bathinda and Chief Engineer, PWD (B&R), Punjab, it was accepted to allow plaster 10mm thick in the interest of quality of surface and to maintain smooth surface which was approved in the meeting.

#### • Regarding providing & fixing aluminium work (Item 7.8 of BWC)

This item was discussed in the 7<sup>th</sup> meeting of Building Works Committee. Since, the rates for openable windows were not provided in the DNIT, it was decided that the openable window shutters will be measured/ paid separately as

per CSR item, since all windows cannot be kept fixed and some need to be kept openable for ventilation etc.

### • Increase in cost due to Tile Face work (Item 8.4 of BWC).

The item of Tile Face work was taken as simple tile masonry in the BOQ, but due to Ornamental Tile Face work being executed as per the drawings, the quantities has increased accordingly. This item was discussed in the 7<sup>th</sup> meeting of Building Works Committee vide item no. 7.7 in the presence of Chief Engineer, PWD (B&R), Superintending Engineer, PWD (B&R), the Additional Chief Architect, Punjab and Prof. Karamjit Singh Chahal from GNDU, Amritsar, wherein it was decided that the case be sent to the Office of Chief Engineer, PWD (B&R) for getting the rates. A letter no. MRSPTU/Estate/17-18/936 dt. 22/11/2017 was sent to Chief Engineer (South), PWD (B&R), Patiala. The Chief Engineer (South), PWD (B&R), Patiala vide his letter no. 163/inrmwx dt. 19/01/18 sent rates as Rs. 8804.07/- per cum. Since the rates were rejected by the agency on the plea that the rates do not match with the item which is to be executed, the matter was referred to the Office of Advisor (Tech). While studying the rates, the Advisor Tech referred the rates for a similar item approved for DAC Amritsar by the Chief Engineer (North), PWD (B&R), Patiala, which was Rs. 20369/- per cum which is similar to the item to be executed at Bathinda. Considering the variation in rates, the Office of Advisor (Tech) to Hon'ble CM, Punjab referred the matter to the University vide letter no. ATPB/448/PWD/EST dt. 5/03/2018 for studying the above rates. Based on which the final rates was to be fixed, but since the rate of Rs. 20369/- per cum was very much higher, the rate was revised keeping in view the rates prevailing in the Bathinda region instead of rates in Amritsar. So, the rate was fixed accordingly @ 13700/- per cum, which was significantly lesser than the rates communicated by the Advisor Tech to Hon'ble CM Punjab(Copies of letters of CE (N&S), letter of Advisor (Tech) to Hon'ble CM, Punjab attached at page no.S-253 to S-261)

- It is clarified that since the BOQ was prepared on the rough drawings keeping in view the urgency of the project, there is always a possibility of change in the quantities of items, which increases the cost. The chart showings the reasons for major increase in project cost is attached atpage no. S-262 to S-263).
- As above mentioned, escalations already approved by the BWC in its 7<sup>th</sup>& 8<sup>th</sup> meetings are to be placed in the forthcoming meeting of the BOG as no meeting

- of BOG was held after 25/04/2018, except the special 8<sup>th</sup> meeting of BOG for a single agenda.
- ➤ It is worthwhile to mention that during the progress of work, Hon'ble Technical Education Minister, Finance Minister and Chairman of BOG, Sh. MP Singh and Sh. DK Tiwari had visited the site and detailed presentations about the process followed and the progress of work was given to them.
- ➤ It is also worthwhile to mention that all works related to construction of new Campus of MRSPTU, Bathinda & subsequent escalation in cost were put in meetings of Tender Finalization Committee, Building Works Committee & Finance Committee as & when required were conducted at the earliest.
- ➤ Escalation:-Escalation asked by the agency and paid by the department is as per provision of the General Conditions of the Contract No. 44. Copies attached at page no. S-264 to S-271 and amount paid is Rs. 38829155/-.
- ➤ Time Extension/ Concession/ Relaxation to the Executing Agency: -Time extension related applications of the agency, Notings of the Estate Office, Approval of the Competent Authority and letters issued by the Estate department are attached at page no. S-272 to S-286. No concession/ relaxation has been granted to the executing agency beyond the provisions of the contract.
- Expenditure incurred on Non Schedule items: As per on-going procedure in the Engineering departments, a Common Schedule of Rates is prepared/ revised by the Committee of the senior engineers of the state/ GOI as applicable. All the items are paid on the basis of the rate approved in the CSR. Any item which is not covered under items of CSR, is called Non ScheduleItem. Items of the project executed so far have been paid as per approved rates of BOQ minus tender saving of 14.58%. Items beyond approved items of BOQ has also been paid on the basis of CSR/ DSR minus tender saving of 14.58% as per estimate vetting letter para no. 2 (d).All the items carried out & paid so far are based on CSR or DSR. Analysis of rates on basis of market rates i.eNon Schedule Items, paid so farisRs. 228780/- which is for extra size of Kota Stone in staircase treads.
- Moreover in addition to above, it is also brought to your kind notice that BOQ/DNIT and project cost was finalized at initial start by the Tech Advisor and final project cost will be taken as cost finalized by Tech Advisor.
- ➤ It is also added that whatever issues cropped up during the construction work, these were taken up & discussed in the meeting of BWC.

- ➤ In all such cases, University has referred these items of escalation to Technical experts including Chief Engineer, PWD (B&R), SE PWD (B&R), Additional Chief Architect, Punjab and representatives of Architect Consultant of the project along with the Estate Deptt. of the University in various meetings of the Building Works Committee of the University.
- ➤ It is to further add that all these Committees are constituted by the BOG itself & minutes of such meetings are always put in subsequent meetings of BOG for approval as a mandatory practice.

# ITEM NO. 10.6 RATIFICATION OF APPOINTMENT AND REQUEST FOR REGULARIZATION OF APPOINTMENT OF DIRECTOR, TRAINING & PLACEMENT.

After advertising this post thrice as per directions of the Board, the post was re-advertised vide advt. no. MRSPTU/ESTB./2018/181 (Annexure-12 from Page No. 103 to 105). Interview of the eligible candidates for the above said post was held on 13.11.2018 under the Chairmanship of Secretary, Govt. of Punjab, Deptt. of Technical Education & Industrial Training, Punjab. Proceedings of the interview is placed at (Annexure-13 at Page No. 106). The appointment letter was issued to selected candidate, on contract basis for a period of 03 years extendable by 02 years depending on performance with a salary of Rs. 100000/- Per month as fixed emoluments, in anticipation of approval of Board of Governors (Annexure-14 from Page No. 107 to 108). He joined on the above said post on 15.11.2018 (F.N.) in the University (Annexure-15 at Page No. 109).

Upon his request and keeping in view his excellent performance on the said responsibility, it is proposed to regularize the appointment of Sh. Harjot Singh Sidhu, Director, Training & Placement in the Pay Scale of Rs.15600-39100/- (Grade Pay Rs. 7600/-) + Rs.5000/- as special allowance to interact with company officials.

Matter is placed before the Board of Governors for ratification of the appointment and consideration of the request for regularization.

### ITEM NO. 10.7 REGARDING INSPECTION OF ELECTRICAL WORK OF UNDER CONSTRUCTION BUILDINGS OF MRSPTU MAIN CAMPUS, BATHINDA.

As decided in the 4<sup>th</sup> meeting of Board of Governors of MRSPTU, Bathinda held on 12.04.2016, the following committee from Giani Zail Singh Campus College of Engg. & Technology, Bathinda was constituted for supervision of construction work of University buildings vide office order no. 6640-6651 dated 28.09.2016:

- 2. Head, Department of Architecture.
- 3. Head, Department of Electrical Engineering.
- 4. XEN of the University as Convener of the Committee.

Dr. Sarabjit Kaur Bath, Head, Department of Electrical Engg., GZSCCET, MRSPTU, Bathinda had shown her inability due to health conditions and also about lack of sufficient relevant experience for above said project. After which she had constituted the following sub-committee for inspection of electrical work in the buildings vide letter no. HEED/5650 dated 12.06.2018 (Annexure-16 at Page No. 110).

- 2. Mr. Tejinder Singh, Lab. Supdt., Electrical Engineering Deptt.

Later on she had also informed that all the three members of sub-committee do not possess the sufficient relevant experience vide letter no. HEED/6524 dated 12.06.2019 (Annexure-17 at Page No. 111). As the inspection of electrical work is time-bound and is being completed in very short period, the following committee has been constituted for the above said purpose with the approval of competent authority (Annexure-18 at Page No. 112):

#### ITEM NO. 10.8 SENIORITY LIST OF FACULTY MEMBERS OF GZSCCET, BATHINDA.

The seniority list dully prepared after taking into consideration the prevailing norms of UGC and replying to the objections raised by the faculty members, the detailed item [6.44] was put up in the 6<sup>th</sup> meeting of Board of Governors of the University, held on dated 25.07.2017. On deliberation, the Board decided that "The seniority list of GZSCCET, Bathinda be prepared as per Government norms and instructions and tentative seniority list may be circulated amongst the all concerned inviting objections if any by giving 15 days notice. The final seniority list may be notified after considering objections by an expert committee to be constituted by the Vice Chancellor.". After which, the item was then put in 7<sup>th</sup> meeting of Board of Governors in the Action Taken Report as "Implemented". Along with constitution of a committee comprising of the following members vide office order no. Uni/Estb./681/7006 dated 01.11.2017 to further resolve the objections, if any (Annexure-19 at Page No. 113).

Prof. (Dr.) D.N. Jauhar, Former Vice Chancellor, Dr. B.R. Ambedkar University (formerly Agra University), Agra, Former Professor and Chairperson, Department of Laws, Panjab University, Chandigarh, Honorary Dean of Faculty of Law, GNDU, Amritsar

- 1. Prof. (Dr.) Raghbir Singh, Ex Dean, Academic Affairs, Guru Nanak Dev University, Amritsar, Presently working as Dean, Academic Affairs Khalsa College, Amritsar
- 2. Prof. Rajinder Kaur, University Institute of Legal Studies, Panjab University, Chandigarh.
- 3. Sh. Gurdeep Singh, Deputy Registrar (Admn.), Maharaja Ranjit Singh Punjab Technical University, Bathinda.

Subsequently, 05 consecutive meetings of the committee were held to resolve the received objections, on 09.11.2017, 12.12.2017, 29.01.2018, 04.05.2018 and 30.07.2018. Findings of the committee was submitted to Chairman BOG vide note no. 5313 dated 12.12.2019 for further decision (Annexure-20 from Page No. 114 to 133).

Matter is placed before the Board of Governors for consideration.

# ITEM NO. 10.9 TERMINATION OF THE SERVICES OF EMPLOYEE ON EX-INDIA LEAVE AND NOT RETURNED ON DUTY AFTER GIVEN PERIOD OF LEAVE.

University has approved Ex-India leave of 60 days to Sh. Gurmit Singh Gill, Lab Supdt., Deptt. of Computer Science & Engg., Giani Zail Singh Campus College of Engg. & Technology, Maharaja Ranjit Singh Punjab Technical University, Bathinda from 05.04.2016 to 03.06.2016 vide office order no. Estb. 94 dated 22.04.2016 (Annexure-21 at Page No. 134). As per rules, he should have joined his duty back on 06.06.2016, but he did not join the duty and sent a mail regarding extension of his leave dated 08.06.2016 and 20.07.2016 (Annexure-22 from Page No. 135 to 138). The University issued him no. of letters via email and registered post to join his duty immediately (Annexure-23 from Page No. 139 to 147). Despite of this, he did not join his duty.

Due to non-sanction of extension in leave and continuous absentia from duty, he was suspended vide office order no. 239 dated 25.11.2016 and a charge-sheet was issued to him vide memorandum no. 1045 dated 10.03.2017, in which it was clearly mentioned that he has to submit his reply within 21 days from issuance of this memorandum (Annexure-24 from Page No. 148 to 155). After non-receipt of his reply within stipulated time, a letter was issued to him as a last chance to submit his reply in next 07 days vide letter no. 1347-1349 dated 07.04.2017(Annexure-25 at Page No. 156).

After this, an email was received from the concerned on 15.04.2017 that he cannot join his duty presently citing family reasons and his son's study and informed to be present on duty in the month of June, 2017 or first week of July, 2017. But the reply of the memorandum was not submitted by the concerned employee till that time. University has then asked him to submit an immediate reply to memorandum issued earlier vide letter no. 1494-1496 dated 20.04.2017 (Annexure-26 from Page No. 157 to 158). After that, he submitted the reply of charge-sheet on 23.04.2017 via email, which was not found satisfactory (Annexure-27 from Page no. 159 to 161).

For further inquiry, a three members committee was constituted vide office order no. Uni./Estb./394/1797 dated 18.05.2017 (Annexure-28 at Page No. 162) and inquiry committee submitted a report vide letter no. Phy/18/341

dated 06.06.2018. The enquiry committee in its report mentioned that "He has not submitted any proof of his wife's illness, which showed that his presence/stay is compulsory alongwith his wife abroad and it does not show any valid reason and/or unforeseen contingencies according to conduct rule 10.3. According to above, the allegations leveled upon the charged employee in his charge-sheet are proved" (Annexure-29 at Page No. 163).

According to the above said report of enquiry committee and as per letter of Punjab. Govt, it is proved that the concerned employee is absent from duty for more than three years and charges leveled upon him are proved.

As per Govt. of Punjab, Deptt. of Finance (Finance Personnel-2 Branch) letter no. 2/1/2017-3FP2/189 dated 12.05.2017, "if an employee is continuously absent from duty more than one year, it will be assumed that he has resigned from his duty i.e. it will be considered as deemed resignation from Govt. service and the concerned employee won't be allowed to join back. Competent authority should initiate the process of termination immediately" (Annexure-30 from Page No. 164 to 165).

Keeping in view of the above, it is proposed that the services of Sh. Gurmit Singh Gill, Lab Supdt., Deptt. of Computer Science & Engg., Giani Zail Singh Campus College of Engg. & Technology, Maharaja Ranjit Singh Punjab Technical University, Bathinda be terminated.

Matter is placed before the Board of Governors for approval.

### ITEM NO. 10.10 REGARDING REPATRIATION OF DR. PRABHJOT KAUR, PROFESSOR FROM I. K. GUJRAL PUNJAB TECHNICAL UNIVERSITY, JALANDHAR TO MRSPTU, BATHINDA.

A letter no. IKGPTU/REG/HRM/877 dated 14.06.2019 from I. K. Gujral Punjab Technical University, Jalandhar was received that Dr. Prabhjot Kaur, Professor wants to join back at Maharaja Ranjit Singh Punjab Technical University, Bathinda (Annexure-31 at Page No. 166).

The brief history of the case is as under:

Giani Zail Singh College of Engg. & Technology, Bathinda was transferred as Constituent College of Punjab Technical University, Jalandhar by Govt. of Punjab vide office order endst. no. 10/102/11-1TE.2/5079 dated 20.12.2011.

- Dr. Prabhjot Kaur, Professor, Deptt. of Architecture, GZS PTU Campus, Bathinda was transferred to Mohali Campus of PTU vide office order no. P.T.U/Reg./02 dated 13.04.2012 of Punjab Technical University, Jalandhar and she was relieved on 10.05.2012 (A.N.) from this College vide office order no. Estb./1053 dated 10.05.2012.
- I.K.G. Punjab Technical University, Jalandhar has demanded the service record vide letter no. PTU/DR/HRD/1536 dated 09.09.2014 of Dr. Prabhjot Kaur and other employees who were transferred from this College to I.K.G. Punjab Technical University, Jalandhar.
- I.K.G. Punjab Technical University, Jalandhar instructed to this College vide letter no. PTU/RO/144 dated 10.07.2014 to put up the matter for permanent absorption of these employees in the meeting of Board of Governors of Giani Zail Singh Campus, Bathinda.
- The matter was put up in the 17<sup>th</sup> meeting of Board of Governors of Giani Zail Singh Punjab Technical University, Bathinda which was held on 22.08.2014 and Board decided that "In view of the acute shortage of faculty and staff at the campus, the Board decided to cancel the transfer/deputation of faculty/staff members from GZS PTU Campus, Bathinda and to direct the concerned employees to join back immediately in the interest of work."
- The letter no. 9497 dated 26.09.2014 and no. 10886 dated 28.11.2014 were written to the Registrar, IKG Punjab Technical University, Jalandhar to bound the officers/officials of this college to join back to Giani Zail Singh P.T.U. Campus, Bathinda which were endorsed to Hon'ble Vice Chancellor and Registrar of IKG Punjab Technical University, Jalandhar.
- In reference to the above said letter IKG Punjab Technical University, Jalandhar written a letter no. PTU/DR/HRD/2063/5234 dated 31.10.2014 to this College that the matter regarding directing the employees of GZS PTU Campus, Bathinda posted at Punjab Technical

- University/PITs of PTU shall be taken up with Board of Governors, PTU and decision whatsoever taken shall be complied with accordingly.
- After that IKG Punjab Technical University, Jalandhar written a letter no. PTU/Reg./5948 dated 09.12.2014 to this college in which clearly mentioned that "The status of faculty and staff mentioned in reference presently working at PTU Main Campus and PITs is transferred and not on deputation."
- On dated 08.10.2015, a meeting was held under the Chairmanship of Sh. Rakesh Kumar Verma, IAS, Secretary to Govt. of Punjab, Deptt. of Technical Education and Industrial Training-cum-Vice Chancellor, IKG Punjab Technical University, Jalandhar and Vice Chancellor, MRS Punjab Technical University, Bathinda. In this meeting it was decided that " On the matter regarding repatriation of Faculty/Staff of GZSCCET, Bathinda presently on deputation with IKGPTU, it was unanimously decided that the faculty/staff now on deputation shall be observed in IKGPTU subject to the approval of Board of Governors and positions held at Maharaja Ranjit Singh State Technical University, Bathinda or its constituent colleges shall be declared vacant. However, before proceeding the cases for absorption, consents of all these faculty and staff members shall be taken".
- Whereas Dr. Prabhjot Kaur was already working on transfer basis at PTU Mohali Campus at that time.
- The matter regarding transfer of employees was placed in the 3rd meeting of Board of Governors of MRS Punjab Technical University, Bathinda vide item no. 3.4 and Board approved it.
- The Registrar, IKG Punjab Technical University, Jalandhar was requested vide letter no. Reg./183 dated 07.01.2016 and Reg./1060 dated 23.02.2016 to depute an officer/official to collect service books and service related documents of all such faculty/staff members.
- These have been handed over to IKG Punjab Technical University on 04.04.2016.
- The full and final payment of GPF/CPF Dr. Prabhjot Kaur, Professor alongwith other 09 (nine) officers/officials was sent to IKG Punjab Technical University, Jalandhar vide letter no. 1849 dated 22.05.2017 alongwith demand draft no. 004773 dated 18.05.2017.
- IKG Punjab Technical University, Bathinda has returned the above said demand draft to this University on 25.02.2019 approximate after a period of two years.
- This matter of loss of interest was put up in the 6th meeting of Finance Committee of this University vide item no. 6.14 and Committee decided that "Demand draft be encashed and both the Vice Chancellors should hold a meeting and outcome of the same be put up before the Board of Governors of University. The concerned employees be informed accordingly".

It is worthwhile mention here that Dr. Prabhjot Kaur, Professor is going to retire/superannuation on 30.11.2021.

If Dr. Prabhjot Kaur, Professor allowed to join back in MRS Punjab Technical University, Bathinda then on her retirement all liabilities and pensionary benefits would be bourned by MRS Punjab Technical University, Bathinda which is cause of huge of financial loss to this University.

Keeping in view the above, Dr. Prabhjot Kaur, Professor or any other out of remaining 09 (nine) officers/officials could not be joined back in this University. However, Dr. Prabhjot Kaur is already working at IKG Punjab Technical University, Jalandhar from more than 08 (eight) years on transfer basis.

It is further informed by Vice Chancellor that the matter was also discussed in 72<sup>nd</sup> meeting of Board of Governors, IKG Punjab Technical University, Kapurthala held on 23.01.2020 and the decision is still pending.

Matter is placed before the Board of Governors for consideration.

### ITEM NO. 10.11 DISPOSING-OFF THE OLD AFFILIATION RECORD OF THE COLLEGE DEVELOPMENT COUNCIL, MRSPTU, BATHINDA.

The office of College Development Council, MRSPTU, Bathinda is in the possession of Affiliation Record of the Affiliated Colleges of the University, w.e.f. Academic Session 2015-16. The affiliation record of the affiliated colleges is accumulating year over year and it is very difficult to manage and store such a huge record. The problem is further intensified by the other records of the affiliated colleges pertaining to complaints and RTIs, which are also handled by the office of College Development Council, MRSPTU, Bathinda.

Keeping the above in view and in tune with the policy of Swachh Bharat Mission, in which, the old record of the various departments has been asked to be disposed off, affiliation record of affiliated colleges of the University, which is more than 3 years old, may be allowed to be disposed off.

Matter is placed before the Board of Governors for approval.

#### ITEM NO. 10.13 CREATION OF TECHNICAL EDUCATION & INDUSTRIAL TRAINING DEVELOPMENT FUND.

A letter was received from the office of Director, Technical Education & Industrial Training, Pb. vide memo no. 292-293 dated 28.02.2018 to create Technical Education & Industrial Training Development Fund (Annexure-32 at Page No. 167). It is brought to the notice of Board of Governors that University has not sufficient funds to run itself. In view of this, University has demanded the grant from the Govt. of Punjab as per of the clause no. 20(1) of the Punjab Act No. 5 of 2015 of the University. Before creating the above said fund, the advice of the Department of Finance, Govt. of Punjab may be sought for the same.

Matter is placed before the Board of Governors for approval.

# ITEM NO. 10.14 REGARDING CLOSURE OF INSTITUTIONS WITHOUT PROPER NORMS AND PENDING DUES BY MANY INSTITUTES AFFILIATED WITH THE UNIVERSITY.

Maharaja Ranjit Singh Punjab Technical University, Bathinda was established by the Govt. of Punjab vide Punjab Act No. 5 of 2015. There were 104 institutes were affiliated the University in 2015. But, due to pending PMS Scholarship payments of SC/ST students with the Govt. of Punjab and receding number of admissions, many institutes were not able to meet their day to day expenditures. Therefore, in the past four years; 2015-16, 2016-17, 2017-18 and 2018-19, 33 institutes have closed their operations. But, in the process most of these institutes have not followed the proper procedure of closure of their institutes with the University and with their statutory approval bodies. Many of them have not even applied for formal closure and have not paid their pending dues.

Most of the institutes had pending loan payments from various banks. The banks have taken formal possession of their land, building and infrastructure. Therefore, the students studying in these institutions would have been left unattended. Thus, in the interest of the students' professional career and their future, the University had to shift the students studying in these institutes to other institutes affiliated with the University as per the choice of the students. But the University cannot keep a blind eye to the violation of institute closure norms and pending dues by these institutes. Therefore, it is proposed to initiate legal action against such institutions to force them to complete the norms and pay their pending dues.

Matter is placed before the Board of Governors for consideration.

#### ITEM NO. 10.15 REGARDING ESTABLISHMENT OF CHAIR IN THE NAME OF GURU NANAK DEV JI.

With reference to letter memo no. 1696-1704/ECC/S-4/2019 Dated 05/11/2019 received from Department. of Technical Education & Industrial Training, Punjab and as desired by Hon'ble Minister of Technical Education & Industrial Training, Punjab the chair in the name of 'Guru Nanak Dev Ji' be established in Maharaja Ranjit Singh Punjab Technical University, Bathinda to align the objectives of Govt. of Punjab to conduct exhaustive research in systematic manner on his messages and teachings of peace, humanity, equality and compassion for creation of better society. The Chair Professor shall work for a period of 5 years on the theme of teachings of Sri Guru Nanak Dev Ji, in particular related to Environmental Science based on "ਪਵਣੂ ਗੁਰੂ ਪਾਣੀ ਪਿਤਾ ਮਾਤਾ ਧਰਤਿ ਮਹਤੂ".

Furthermore, Guru Nanak chair would enable studies that would have special focus on scientific vision of Guru Nanak in addressing prevalent issues such as bio-hazard threat, ecological imbalances and defining ecological relationships for the better survival of every living organism on this earth. The chair will particularly emphasize on scientific perspective of Nanak teachings that are conducive and valuable in comprehending the scope of the vision of the Sikh Gurus particularly in context to ecology and environmental Science.

#### ITEM NO. 10.16 TO RATIFY THE EXPENSES INCURRED FOR PRINTING OF CITATION BOOKLET AS DESIRED BY GOVT. OF PUNJAB.

Recently a case for printing of citation booklet (Qty. 650 No's) has been received from Govt. of Punjab. Department of Tourism & Cultural Affairs on the special occasion of 550<sup>th</sup> year celebrations of Shri Guru Nanak Dev Ji (**Annexure-33 from Page No. 168 to 171**). The Vice Chancellor given the approval to process the case for printing of Citation Booklet by constituting a purchase committee (**Annexure-34 at Page No. 172**).

As per prevailing purchase rules of university Goods/works amounting below Rs. 2.00 Lac is to be processed through calling quotations & Rs. 2.00 Lac or above through e-tender. But in this case due to acute shortage of time, it is not possible to process the case through tender as the cost of the citation booklet is more than Rs. 2.00 lakh.

So, keeping in view the above and to complete the assigned work in stipulated period Vice Chancellor given the approval to process this case through Spot Purchase Committee.

Matter is placed before the BOG for ratification & in future Vice Chancellor of University may please be authorised to relax the rules & execute the purchase by constituting a Spot Purchase Committee for emergent purchases under exceptional and unavoidable circumstances.

Matter is put up before the Board of Governors for ratification.

#### ITEM NO.10.17 IRREGULAR PAYMENT OF SECRETARIAT PAY TO UNIVERSITY EMPLOYEES.

Punjab Govt., Deptt. of Higher Education (Education-1 Branch) memo no. 13/32/2019-4 Ph 1/1556647/1-3 dated 26.08.2019 conveyed that as per directions of Punjab Govt. dated 13.10.2010 and 15.12.2011 has conveyed as reproduced that "The Governor of Punjab is pleased to decide that the certain categories of employees working in the Punjab Civil Secretariat shall be entitled to Secretariat Allowance at the rates mentioned in the Annexure enclosed to this letter. This decision shall also be applicable to the similar categories of employees working in the offices of Punjab Vidhan Sabha. Financial Commissioner's Secretariat, Punjab Raj Bhawan. Legal Remembrancer and Punjab Public Service Commission."

In this matter, Punjab Govt., Deptt. of Finance (Finance Personnel-2 Branch) had given their clarification/ advise as under:

"Universities have never been equated with Civil Secretariat Office of Punjab Government by the Government of Punjab and hence any benefit granted to Punjab Government Secretariat employees cannot be made applicable to University employees." So, the payment of secretariat pay to employees working in Universities should be stopped with immediate effect (Annexure-35 at Page No. 173).

Board in its 5<sup>th</sup> meeting vide item no. 5.11 was informed that "Dr. Buta Singh Sidhu is a regular employee at IKG Punjab Technical University, Jalandhar, hence, his lien cannot be extended. However, keeping in view that University has been created by bifurcation of erstwhile IKGPTU, therefore, on the recommendations of Vice Chancellor, MRSPTU, it was decided that Dr. Buta Singh Sidhu may be given an option to move back to MRSPTU, Bathinda, as such in his present capacity with the stipulation that his services will be covered by the terms & conditions applicable to him at IKGPTU, which will be personal to him, till his retirement (Annexure- 36 from Page No. 174 to 176).

Dr. Buta Singh Sidhu relieved by IKG Punjab Technical University vide letter no. IKGPTU/REG/772 dated 27.10.2016 and joined in this University on dated 28.10.2016 (**Annexure-37 at Page No. 177**).

His salary has been fixed as per his Last Pay Certificate issued by IKG Punjab Technical University vide no. PTU/F&A/FO/763 dated 27.10.16 (Annexure-38 at Page No. 178).

As per his last pay certificate, he was drawing Rs. 2500/- (Two thousand five hundred) as Secretariat Pay. The same was protected by this University. Now as per Punjab Govt. memo dated 26.08.2019 the, employees working in Universities are not entitled for Secretariat pay.

In view of this, secretariat pay of Dr. Buta Singh Sidhu has stopped with immediate effect vide letter no. 4342 dated 17.09.2019 (Annexure-39 Page No. 179).

Matter is reported to the Board of Governors for information.

#### ITEM NO. 10.18 RATIFICATION OF STAFF SELECTED FOR THE POSTS OF CLERK-CUM-DATA ENTRY OPERATOR ON REGULAR BASIS.

The item was put up in the 9<sup>th</sup> meeting of BOG vide agenda item no. 9.17 and Board decided that "Agenda item to be put up in next meeting along with compiled data of total number of posts sanctioned and filled in clerical staff" (Annexure-1 at Page No. 62). As per decision of the Board the compiled data of total number of posts annexed at (Annexure- 40 at Page No. 180).

The posts of Clerk-cum-Data Entry Operator were advertised in leading newspapers and the last date of receipt of applications was 08.08.2017 (Annexure-41 from Page No. 181 to 185). The selection has been carried out as per the selection criteria approved by Board of Governors in its 2<sup>nd</sup> meeting.

Punjabi and English Typing Tests for this post were conducted on 12.02.2018 and 13.02.2018 and the candidates who had qualified both tests were called for Computer Proficiency Test on 10.05.2018. The relevant details are as under:

#### ITEM NO: 10.19 RATIFICATION OF APPOINTMENT OF SDO (E) IN THE UNIVERSITY.

The item was put up in the 9<sup>th</sup> meeting of BOG, wherein the details were asked to be put up in the next meeting (Annexure-47 from Page No. 196 to 198).

It is informed that two posts of S.D.O. are sanctioned by BOG in its 2<sup>nd</sup> meeting and at present both positions are vacant (**Annexure-48 at Page No. 199**). It is further added that University did not have any experienced Officer for supervision of electrical works and related matters for the ongoing construction works. There were two alternatives either to get SDO (E) on deputation from another Department or get the same with appropriate experience among retired officials from concerned Departments.

The nature of work of Sub Divisional Engineer of PSPCL does not match the nature of work in the University. Other related departments with similar nature of work are PWD B&R and Punjab Mandi Board. The jurisdiction of the University works is spread over almost half of the State area, whereas in routine, SDO's jurisdictions are in a limited area almost similar to an SDO (Civil). Keeping this difficulty in view and to control the scattered work, no in-service SDO was expected to respond for the above post.

Ultimately, the University had the only way to get a retired SDO (E) from PWD B&R and Punjab Mandi Board. As no retired SDO (E) was locally available below the age of 65 years from PWD B&R, the matter was then discussed with Local Mandi Board authorities and they apprised that Sh. Hardeep Singh, SDO (E), Punjab Mandi Board has retired recently and he had also executed similar nature of works in this area including Meritorious School, Fish Market, Stadiums etc. Accordingly, he was contacted and got agreed to join. He has been appointed as Sub Divisional Officer (Electrical) in this University vide letter no. 3876 dated 26.12.2018 for a period upto 31.03.2019 or till the completion of Campus of University, whichever is earlier on consolidated salary (Annexure-49 from Page No. 200 to 202). This was further extended w.e.f. 01.04.2019 vide letter no. 2009 dated 28.05.2019 till the completion of University Campus (Annexure-50 at Page No 203).

Matter is placed before the Board of Governors for ratification.

# ITEM NO. 10.20 RATIFICATION OF NEW APPOINTMENT OF SENIOR ASSISTANT (LEGAL), MAHARAJA RANJIT SINGH PUNJAB TECHNICAL UNIVERSITY, BATHINDA.

University advertised various posts vide advertisement no. MRSPTU/ESTB./2019/DPR/247 in leading newspapers. Out of which, the post of Senior Assistant (Legal) on regular basis was also advertised and the last date of receiving applications was 19.08.2019 (Annexure-51 from Page No. 204 to 206). Total 07 (seven) applications were received till last date. The proposed criteria for the post of Senior Assistant (Legal) was then sent to Hon'ble Principal Secretary to Govt. of Punjab, Deptt. of Technical Education & Industrial Training, Pb-cum-Chairman, Board of Governors, MRSPTU, Bathinda vide note no. 4866 dated 24.10.2019 and the same was approved by their diary no. 1466 dated 25.10.2019 (Annexure-52 at Page No. 207). Out of 07 (seven) candidates, 06 (six) candidates were found eligible for the above said post. As per the criteria approved, test for Domain Knowledge was held on dated 08.01.2020 for eligible candidates. Only 01 (one) candidate had qualified the test (Annexure-53 from Page No. 208 to 209).

Again a note no. VC/PA/902 dated 16.01.2020 was put up to the Principal Secretary to Govt. of Punjab, Deptt. of Technical Education & Industrial Training, Pb-cum-Chairman, Board of Governors, MRSPTU regarding panel and selection committee for direct recruitment of Senior Assistant (Legal) in the University (Annexure-54 at Page No. 210). As per approval received from the Hon'ble Chairman, Board of Governors, the interview for the above said post was conducted on 04.02.2020. Proceeding of the same was placed at (Annexure-55 at Page No. 211).

Matter is placed before the Board of Governors for ratification.

#### ITEM NO. 10.21 REGARDING REMUNERATION FOR THE INCOME TAX CASES OF THE UNIVERSITY.

The Notices U/s 143(3) of the Income Tax Act, 1961 were received by the University for the Financial Year 2016-17 (A.Y. 2017-18) on dated 20/11/2019 (Annexure-56 from Page No. 212 to 224). In this notice, an amount of Rs. 6,48,96,550/- has been demanded as tax Liability. For this, an appeal is required to be filed within 30 days from the passing of the order.

In view of urgency, the University has hired the services of renowned Advocate, Sh. Parshotam K. Singla, who is expert in handling the Income Tax case of the educational institutions like MIMIT Malout, Guru Kashi University, Baba Farid Group of Institutions etc. with a remuneration of Rs. 50,000/- (Rupees Fifty Thousands only) for the case to be dealt at Bathinda only (Annexure-57 at Page No. 225).

In addition of this, it is stated that for outside appeals i.e. at Chandigarh, Amritsar etc. the legal fee charged by the renowned Advocate/ Chartered Accountant (CA) is upto Rs. 1,00,000/- (Rupees One Lac only).

Hence, it is proposed that hiring of services of Sh. Parshotam K. Singla may please be ratified and further suitable decision may please be taken for outside Bathinda jurisdiction i.e. like Chandigarh, Amritsar, Jalandhar etc. as there is so much variation in legal fee charged by Advocate/CA as per their expertise and experience.
