## OFFICE ORDER

Consequent upon the approval of Higher Authority vide diary no. VC/1753 dated 27-07-2020, the Fee Structure of the University Main Campus and Constituent Colleges of Maharaja Ranjit Singh Punjab Technical University, Bathinda shall be as under.

1. The fee structure of various courses offered at University Main Campus and Constituent Colleges shall be applicable for the year 2020-2021 as notified by the University earlier for the academic session 2019-20.
2. The various scholarships and promotional schemes shall also be same as per the previous year, except for the PIT(s) GTB Garh, Nandgarh and Rajputa shall be as under.
  - a) A discount of 20% in Tuition Fee and Development Fund shall be applicable as 'PIT Admission Promotion Scheme' (PITAPS) at these PITs except for B. Tech., M. Tech. and MCA courses.
  - b) Chief Minister Scholarship Scheme (CMSS) may be extended to these PIT's students as follows
    - i. 50% Tuition fee waiver whose score is equal or more than 70% in qualifying exam.
    - ii. 30% Tuition fee waiver whose score is between 60% to <70% in qualifying exam.

## NOTIFICATION

Sub.: "Chief Minister Scholarship Scheme" for Academic Session 2019-20 for MRSPTU Main Campus and all Constituent Colleges.

### I. B. TECH., B. TECH. (LATERAL ENTRY) & B. PHARM.

#### 1. Category A

JEE Rank	Scholarship equivalent to
Rank $\leq$ 50,000	Full Tuition Fee
50,000 < Rank $\leq$ 1 Lakh	75% of Tuition Fee
1 Lakh < Rank $\leq$ 1.5 Lakh	50% of Tuition Fee

NEET Rank	Scholarship equivalent to
Rank $\leq$ 25,000	Full Tuition Fee
25,000 < Rank $\leq$ 1 Lakh	75% of Tuition Fee
1 Lakh < Rank $\leq$ 1.5 Lakh	50% of Tuition Fee

#### 2. Category B

Students in first 6 merit positions of any board examination, but must have appeared in JEE test and admitted in any branch: Scholarship equivalent to Full Tuition Fee.

#### 3. Category C

All University/Board toppers in qualifying examinations - Scholarship equivalent to Full Tuition Fee.

#### 4. Category D

(a) **For University main campus & GZSCCET, Bathinda:** Candidates having 80% marks and above in the qualifying examination are entitled to Scholarship equivalent to Half Tuition Fee.

(b) **For PITs:** Candidates having 70% marks and above in the qualifying examination are entitled to Scholarship equivalent to Half Tuition Fee.

### II. M. TECH., M. PHARM. & M. ARCH.

1. **Category A** — GATE/GPAT qualified candidates will get scholarship equivalent to 50% Tuition Fees, in case they do not avail any other scholarship.

2. **Category B** — Scholarship equivalent to Full Tuition Fee will be provided to all University/ Toppers.

### III. B.ARCH.

Average of 10+2 %age and NATA %age	Scholarship equivalent to
More than 80%	Full Tuition Fee
More than 70% and upto 80%	75% of Tuition Fee
More than 60% and upto 70%	50% of Tuition Fee
JEE Rank in Arch. App. Test	Scholarship equivalent to
From 1 to 7500	25% of Tuition Fee
More than 7500 upto 10000	15% of Tuition Fee

**IV. M.Sc. (CHEMISTRY / PHYSICS / FOOD SCIENCE & TECH. / MATHEMATICS) / MATHEMATICS & COMPUTING / CLINICAL RESEARCH), MBA, MCA, MCA (Lateral Entry) / M.COM. and any other PG courses.**

1. Scholarship equivalent to Full Tuition Fee will be provided by the University to the Merit position holders in the qualifying examinations as declared by the respective University.
2. **For University main campus & GZSCCET, Bathinda:** Scholarship equivalent to 50% Tuition Fee will be provided by the University to the candidates who have secured more than or upto 80% marks in the qualifying examinations.
3. **For PITs:** Candidates having 70% marks and above in the qualifying examination are entitled to Scholarship equivalent to Half Tuition Fee.

**V. ANY OTHER UG PROGRAMME OFFERED:**

1. **For University main campus & GZSCCET, Bathinda:** Candidates having 80% marks and above in the qualifying examination: Scholarship equivalent to Half Tuition Fee.
2. **For PITs:** Candidates having 70% marks and above in the qualifying examination are entitled to Scholarship equivalent to Half Tuition Fee.


**General Conditions for continuation of scholarship in higher semesters.**

- (a) He/She must clear all his/her previous semesters.
- (b) He/She must obtain atleast 7 SGPA in each semester.
- (c) A student can avail only one scholarship at a time.
- (d) He/She must have shown appropriate/good conduct throughout the session.

**Note:**

1. The above notification supersedes earlier decision/notification (if any) issued in this regards.
2. The above said scheme will be implemented only to the students admitted in 2019-20 academic session.
3. The benefits of 'Chief Minister Scholarship Scheme 2019-20' are extended to Punjab as well as other states candidates also.
