In the light of UGC Guidelines vide no. D.O.No.F.1-1/2020 (Secy) dated 22.09.2020 (Copy enclosed at Annexure-I) and as approved vide no. VC/2142 dt. 27.10.2020, the refund of fees be made on account of all cancellation of admissions/ migration of students, for the 2020-21 session as under;

To be crystal clear, the entire fees including all charges be refunded in totality (Zero cancellation charges) on account of cancellation / migration up to 31.12.2020, the entire fee collected from a student be refunded in full after deduction of not more than Rs. 1000/- as processing fee.
