
PUBLIC APPOINTMENTS

Applications received late shall not be considered and will be summarily rejected.

Qualification & Eligibility:**1. Dean Academics (on deputation basis):**

The candidate should be one of the top educationists and eminent scholar from the Govt. Departments/Central/State Universities. Should be working as Professor/equivalent with Ph.D. degree in the relevant discipline.

Terms of appointment:

- i The appointment shall be made on deputation basis for a period of 03 years (extendable to one more term of three years) on usual deputation terms of the Punjab Govt.
- ii The candidate must not be more than 57 years of age at the time of interview.

GENERAL INSTRUCTIONS FOR ALL CANDIDATES:

The eligible candidates must apply online and send by post duly signed print-out (hard version) of the application(s).

1. The fee Rs.590/- (Rs.295/- for SC/ST candidates) including GST @18% can be submitted through Demand Draft in favour of "The Registrar, MRSPTU, Bathinda" payable at Bathinda along with the application should reach the office of Registrar by **31.05.2023** through Speed/Regd./Personally.
2. The University reserves the right to fill/not to fill any or all of the above posts. Application fee will not be refunded/adjusted in any case.
3. The candidates are required to clearly mention conversion formula of CGPA to the percentage marks and percentage of marks in the appropriate place.
4. The University will not be responsible for non-receipt/ late receipt of application due to postal delay.
5. Incomplete applications will be rejected without entering into correspondence.
6. The candidate must ensure that the email address and mobile number provided in the online application are correct and active. Further, the candidates should ensure the completion of all columns of online application form.

7. Candidates are advised to exercise extreme care to ensure that they meet the eligibility criteria for the post they are applying.
8. Candidates will be eligible only if he/she has degree certificate/ Gazette result notification/ all original DMCs issued on or before the last date of application. Any Provisional Certificate for any degree issued prior to Gazette result notification will not be considered. Self-attested photocopies of all these certificates must be attached with the application.
9. Candidate must paste his/her passport size photograph on the application form.
10. As per the decision of the BOG to attract faculty members from all over India and abroad, the candidates shall be selected without insisting on matric level Punjabi language qualification. They will be encouraged to learn functional Punjabi equivalent to Matric level within 03 years for all the teaching posts.
11. Person already in Govt. service must send their applications through their employer. However, they can send an advance copy directly followed by the application through proper channel.
12. The period of time taken to acquire M.Phil and/or Ph.D shall not be considered as teaching/research experience to be claimed for appointment to the teaching post.
13. Candidates claiming any advantage of the reservation category will submit an attested photocopy of their latest valid certificate issued by the competent authority.
14. Knowledge of the Computer is essential for all the posts.
15. The instructions regarding Pay Scale/Salary issued by the Govt. of Punjab (Deptt. of Finance/Deptt. of Technical Education) from time to time will be applicable.
16. Weightage for Experience and Research Publications, shall be given only if supporting documents are annexed with hard copy of the application.
17. Candidates who are applying for the above said post i.e. Dean Academics (on deputation basis) are required to send 05 (five) copies of their application along with reprints of 10 major publications and must attach Proforma for Academic Research Score (ARS) duly filled in all respect as per the University Grants Commission Regulation, 2018 vide no. F.1-2/2017(EC/PS) dated 18.07.2018 to the University for the perusal of experts.

Note: The candidates who have already applied for the above said post against advt. no. MRSPTU/ESTB./2023/DPR/473 shall not be required to apply again. However, in case they wish to update their profile, they may apply online in the same manner.
