
- i. The Department is presently approved by COA and AICTE with the name "Department of Architecture, GZSCCET, Bathinda" and the name change has to be intimated to both the statutory bodies. Moreover, the new premises will be inspected by COA for space and infrastructure before the new name is considered for approval. Therefore, the members felt that the existing name may be continued till all approvals are applied for to the concerned bodies and permissions are sought.
- ii. Also, AICTE approval (though not mandatory) for Architecture, must be sought for getting benefits under MODROBS and other AICTE schemes for faculty and students. Therefore, the modalities regarding seeking approval must be discussed with university authorities.
- iii. There were some concerns raised by members regarding service conditions, age of superannuation, and extension of service after superannuation etc. It was decided that suitable time for a meeting of faculty/staff with Hon'ble Vice Chancellor and Registrar, MRSPTU regarding the clarification of the above mentioned issues shall be sought.



Minutes of the meeting related to Board of Control of Department of Architecture, MRSPTU, Bathinda held on October 17, 2018 at 3:00 PM in the Office of HOD, Department of Architecture

- a) The members deliberated in detail and at length the implications of renaming of the Department of Architecture, GZSCCET to School of Planning of Architecture and came to the following conclusion that:
 - i. New nomenclature involving removing the prefix GZS will adversely impact the future functioning, admission, credibility and identity of the institution.
 - ii. During the last 29 years of existence, the Department has made a mark in the field of Architectural education in the profession and the state. Change of name can impact the employability and future of the students.
 - iii. Implications of the transfer of the faculty and employees from Department of Architecture, GZSCCET to MRSPTU, Bathinda in terms of service conditions and retirement benefits needs to be studied in detail before taking a final decision in this regard.
 - iv. The implication of change of name of the institute in terms of approvals, from statutory bodies including CoA, AICTE, DTE&IT in terms of procedure and finances needs to be studied in detail before taking a final decision in this regard.
- b) The members felt that university should start the Bachelors and Masters level courses in Planning with the intake of 30 and 15 respectively, from the next academic session as per the decision of the academic council. Additional faculty and staff needs to be identified and recruited for these courses before their commencement.
- c) In addition, it was felt that university can start the Bachelors level course in Fine Arts and Interior Design, which has lot of synergy with the profession of Architecture. The intake of 20 may be kept for these courses.
- d) The members were of the opinion that in order to provide wider exposure to the students regarding latest technologies and practices in the profession, Workshops of 3-5 days duration involving eminent professional/ academicians should be organized on regular

basis based on remuneration @ Rs. 5000/- per day per expert with permission to travel by Air.


- e) The members were of the opinion that there is no need to increase the current intake in the B.Arch. course since new courses in Planning, Interior Design and Fine Arts are being proposed from the next Academic year.
- f) Members felt that possibility of holding collaborative programmes with institutions of National/ International repute imparting Architectural education needs to be explored on priority in order to share best practices in Architectural education.







- a) The members suggested the new name of School of Planning and Architecture, MRSPTU, Bathinda (Previously, Department of Architecture, GZSCCET, Bathinda) as "GZS School of Architecture and Planning, MRSPTU, Bathinda"
- b) The members decided that the syllabus for new courses, (i.e., M.Planning and B.Interior Design) starting from Session 2019-20, must be prepared and meeting of BoS for Architecture and Planning be conducted by end of January, 2019. Additional posts for faculty and staff needs to be sanctioned for these courses. For syllabus formulation, Prof. Jit K. Gupta (Retd. Senior Town Planner) may be approved as permanent member of BoS in Arch. & Planning.
- c) Academic Ordinance for B.Arch. course shall be prepared by Prof. Bhupinder Pal Singh Dhot and Ar. Mitakshi Sharma before conduct of BoS meeting.
- d) It was decided that the Extension of Approval (EoA) of B.Arch. course may be sought from Council of Architecture for 2019-20 with the new name "GZS School of Architecture and Planning, MRSPTU, Bathinda" with the infrastructure and facilities as per the current location in GZSCCET, Bathinda since the new building may not be occupied by the time of inspection. The application form for COA shall be processed by Dr. Jatinder Kaur, Ar. Meenu Chaudhary, Ar. Guneet Kaur and Sh. Rajbir Singh. Any faculty/ staff members may be co-opted for preparing and submitting the report in time.
- e) It was also decided that AICTE approval for B.Architecture course must also be taken in the interest of students. For this purpose, closure must be applied by DAA, GZSCCET, Bathinda and new login must be created by DAA, MRSPTU, Bathinda.
- f) It was discussed that process of purchase of new books has not been initiated till date for session 2018-19. As per COA norms, additional 50 titles must be added every year. For this purpose, the purchase of new books must be initiated immediately. The budget for the books has been already submitted to the librarian by the Department.

- g) Members felt that the faculty members must attend/ organize workshops and seminars for faculty growth to upgrade their academic skills and to promote interaction with leading institutions/ organizations.
- h) The mission and vision of the Department shall be prepared by Dr. Jatinder Kaur and Ar. Amandeep Kaur. The list of 10 prominent alumni will be prepared by Ar. Ranjeet Kaur and Ar. Kapil Arora.
- i) The teaching load for next session was deliberated and it was decided to give a teaching load of 14 to Associate Professor and 16-18 to Assistant Professors. There is a requirement for 04 additional faculty members for a teaching load of 62. Therefore, at least 2 faculty members must be recruited on consolidated basis and 2 on Lecture basis. Furthermore, it was impressed upon that full time faculty members add value to the overall teaching learning process because of their full time presence in the Department.

- iv. A proposal to organise one day ECBC workshop cum exhibition has been received for D2O services, LLP, PEDDA and BEE on 20.02.19. The Department shall conduct the workshop in the MRSPTU, Campus, but all expenditure shall be borne by D2O services.

An estimated expenditure of Rs. 5,000/- may be incurred for venue decoration & stationery. The members recommended the conduct of the workshop.

2. It was also discussed that the **Regular faculty posts** for Masters' courses in Architecture and Planning must be created and regular faculty be recruited at the earliest to ensure quality education in these courses.
3. It was discussed that the **Regular faculty/staff positions** for Professor, Associate Professor, Graphic Artist and Draughtsman which were advertised and applications for the same had been received, must be processed for recruitment at the earliest to fulfil Council of Architecture norms (Annexure B) and for smooth functioning of department.
4. A committee comprising of Prof. Ripu Daman Singh and Prof. Amandeep Kaur, was constituted at the department level to prepare suggested norms for Payment to students, Provision of University vehicle etc. related to **Educational Tours in Architecture and Planning Courses**, which are an essential part of Academic curriculum and are Credit courses.
5. The members suggested that **University Practical examinations** must be conducted by **External Faculty**, since practical subjects in Architecture needs professional inputs and exchange of ideas from varied pool of professionals and academicians of leading offices and institutes. The list of External examiners is a part of COA Annual report.

- a) A decision regarding shifting of Department from GZSCCET, Bathinda to MRSPTU, Bathinda was taken in 7th BOG meeting of MRSPTU, Bathinda and the notification regarding the same was issued vide Ref. No. Reg/Notification/077/1533 Dt. 24.05.2018.

Therefore, in wake of the notification, the Department (Physical infrastructure and all students of B.Arch- All batches) should shift to the new Department building (nearing completion in the name of GZS School of Architecture & Planning, MRSPTU, Bathinda.

b) Upto 2019, the approval of AICTE was also taken along with other Engineering courses by GZSCCET MRSPTU, Bathinda. Now, as a University Department, AICTE approval need not be sought along with GZSCCET MRSPTU courses since AICTE approval is not mandatory for University Departments (e.g., Architecture Department of GNDU, LPU, Chandigarh University etc.). It is also proposed that admission of B.Arch. course 2020-21 should be done under MRSPTU main campus and the same must be reflected in University brochures, Notifications, Advertisements etc.

The administrative decision related to S.No. 1 (b) should be taken by University higher officials.

c) Since COA is the apex body regulating Architectural education in India, therefore, only COA approval shall be sought under the new name (GZS School of Architecture & Planning, MRSPTU, Bathinda) for B.Arch. course.

The following issues was discussed and recommendation made for approval:

1. Students of 7th sem.(2017 Batch) have requested to postpone their 6 months Practical Training to July-Dec.2021(9th sem.) instead of Jan. – July 2021 (8th sem.) due to the ongoing Pandemic. In this matter all parents are reluctant to send their wards to different places for Practical Training. Moreover the Architectural Firms are not willing to hire Trainees during this period. So, considering all the facts & the ongoing situation of COVID, it is suggested that the practical training for the B.Arch (2017 batch) which is scheduled from Jan-July, 2021 can be shifted to 9th semester (July-December, 2021). This would be a one-time change only due to the Covid situation. In lieu of this 9th sem.subjects/scheme will be followed in 8th sem. Approval may be sought from Dean, Academic Affairs for this. All issues related to this will be resolved by COE.
2. During admission 2020 for PG courses, it has been noticed/ Observed that most of the aspirants want to pursue part time M.Arch as most of them are already working in various firms. So, it is suggested that Part time M.Arch should be started from the next session (July, 2021).
3. The issue regarding calling the students into the campus for Viva-voce has discussed and in the same context both online/offline mode will be offered. For this, it was also decided that the local students can be called for physical mode. For this, subject in charge/ class co-ordinators are advised to contact the willing students for the same.

The following issues were discussed and recommendations made for approval:

1. On the request of students & their parents, Practical Training of 6 months (B.Arch 2017 batch) was postponed from 8th semester (Jan – July, 2021) to 9th semester July to December, 2021 as a one time change due to COVID. The same was approved by member of BOS through e-mail. Due to ongoing situation of pandemic, it is not possible to send the students to various offices in the country for training. Therefore it is recommended that the practical training further be shifted to 10th semester (Jan – July, 2022). In lieu of this, the semester subjects/scheme of 10th semester shall be followed in the 9th semester.
2. Regarding soft skill training (after B.Arch 2nd semester, 2020 batch) it was decided that the soft skill training at the end of 2nd semester shall be conducted in online mode due to the current pandemic situations. The on-site training (after B.Arch 4th semester 2019 batch) should be shifted at the end of 5th semester as it is not possible to send the students to construction sites in the current situation.
3. In the ongoing semester, the subject of Educational Tour – 1 (BARC1-432) of B.Arch 4th semester having one credit it was decided that it is not possible to conduct physical educational tour for the students. Therefore the students shall study a monument as allotted to them by the subject incharge through online mode/VR application etc., so that the evaluation of the subject can be carried out.
4. Regarding elective subject Architectural building services of B.Architecture 9th semester subject code BARC1-967 and another subject of Professional practice B.Arch 10th semester subject code BARC1-X60, the detailed contents were not uploaded in the 2016 syllabus of


- B.Architecture. Therefore the same are attached herewith for uploading in the syllabus file of B.Arch 2016 syllabus file.

6. Some subjects of M.Planning (1st & 2nd semester) have similar content & minor changes, for which little modifications in contents are being done in the syllabus.



7. It is proposed that from now onwards theory lectures shall not be adjusted but will be rescheduled.
8. As per the current scenario of MRSPTU departments are required to take 05 assignments and to conduct 02 quiz per subject in a semester. On considering the quantum of studio work in courses which are being run under GZSSAP, it is suggested that 04 assignments and 01 quiz per subject to be opted.






