In this regard, the following proposal has been framed to offer multi exit options to the graduating students of the University:

- 1. An additional skill course relevant to the undergraduate course/branch shall be offered by the concerned department at the time of admission of student in the first year of that undergraduate course.
- 2. This skill course shall run parallel and shall have no bearing on the normal undergraduate degree course. Moreover, this skill course shall not be mandatory but optional for the students to take.
- 3. The student shall be given Certificate/Diploma/Advance Diploma depending upon the time of exit of student, provided the student has completed all requirements of passing the First/Second/Third Year respectively of his undergraduate degree course.
