ITEM No. 3.1 CONFIRMATION OF THE PROCEEDINGS OF 2nd (LAST) MEETING OF BOARD OF GOVERNORS OF M.R.S.S.T.U. BATHINDA.

The 2nd meeting of Board of Governors of the University was held on 07.09.2015 at Mahatma Gandhi State Institute of Public Administration, Chandigarh. TO REPORT ACTION TAKEN ON THE DECISIONS TAKEN IN THE 2nd (LAST) MEETING OF BOARD OF GOVERNORS OF M.R.S.S.T.U. BATHINDA HELD ON 07.09.2015.

ITEM No. 2.1 Confirmation of the proceedings of 1st (First) meeting of Board of Governors of M.R.S.S.T.U. Bathinda.

Decision Taken: Confirmed. The comments of Director Technical Education may be incorporated in the minutes.

ITEM No. 2.2 The rest of Action Taken Report is approved except item no. 1.6 with following directions in respect to the following items:

(i) <u>Item no. 1.5</u> The committee be requested to complete the assignment within 2 months.

Action Taken: The decision conveyed to the Committee.

(ii) <u>Item no. 1.6</u> The advertisement be circulated to all colleges and universities of the state.

Action Taken: Decision implemented.

(iii) <u>Item no. 1.7</u> A separate agenda item for amendment in the MRSSTU Act of 2014 in regard to setting up of Autonomous College as per UGC guidelines be brought up after considering the application of Shaheed Bhagat Singh State Technical Campus, Ferozepur for grant of status of Autonomous College, if it is found eligible by the University.

Action Taken: The case of grant of Autonomous College status to SBS State Technical Campus, Ferozepur is being put up as separate item no. 3.3.

(iv) Item no. 1.9 All the employees of MRSSTU, Bathinda or its constitutent college GZSCCET, Bathinda shall be directed to join back their parent institute. The faculty members who are working in PIT, Mansa in the pay scale of IIT(s), would be given the UGC pay scales and their pay would be protected.

Action Taken: A meeting of both the Vice Chancellors of MRSSTU and IKG PTU alongwith Registrars was held on 08-10-2015. A separate agenda item is placed for approval of the Board of Governors at item no. 3.4.

(v) <u>Item no. 1.10</u> Deputation will not be allowed between two technical Universities. However, on demand of the host institution with recommendations of respective Vice-Chancellor the case be considered by respective BOG(s) of the University.

(vi) Item no. 1.13 The Society of GZSCCET, Bathinda being Govt. Society shall be dissolved and the necessary action in this regard will be initiated by Department of Technical Education & Industrial Training, Pb. It is clarified that GZS Campus College of Engg. & Technology, Bathinda shall not have separate Board of Governors and like other constituent colleges shall be governed by Board of Governors of the University.

ITEM No. 3.3 AN AUTONOMOUS COLLEGE STATUS TO SHAHEED BHAGAT SINGH STATE TECHNICAL CAMPUS, FEROZEPUR.

The matter regarding grant of autonomous status to SBSSTC, Ferozepur was taken by MRSSTU to the BOG in its second meeting held on 07-09-2015 (Item no. 1.7. It was decided to make the proposal for amending the MRSSTU act for creation of autonomous colleges as per UGC guidelines.

The following steps have been taken:

- 1. The Director, SBSSTC was asked to submit the detailed application sent to UGC along with all documents vide letter no. Reg/1338 dated 15-09-15 (Annexure-III from page no. 43 to 44), so that the case of grant of autonomy to the institute could be prepared and presented at the BOG's next meeting. But, the institute did not provide any such documents, the reply of the Director, SBSSTC is attached at (Annexure-IV from page no. 45 to 47).
- 2. A meeting was held with the Director, SBSSTC in the office of the Vice-chancellor on 01-10-2015. The Director, SBSSTC was asked again to submit the required documents but he did not supply even a copy of the institute's application submitted to UGC for grant of autonomy.
- 3. The university, then asked for the relevant documents from the IKGPTU, Jalandhar vide letter no. Reg/1695 dated 01-10-2015 (Annexure-V from page no. 48 to 49). But, IKGPTU also has not provided any of the documents asked for. Their reply of the letter and documents supplied is attached at Annexure-VI from page no. 50 to 53.
- IKGPTU, Jalandhar has given approval of academic autonomy to SBSSTC, Ferozepur vide letter no. IKGPTU/Reg/10075 dated 19-08-15 (Annexure-VII at page no. 54). It may please be noted that on this day i.e. 19-08-15, SBSSTC was affiliated with MRSSTU, Bathinda and not IKGPTU, Jallandhar. Colleges located in eleven Districts of Punjab including Ferozepur imparting Technical Education were notified as deemed to be affiliated to MRSSTU, Bathinda vide notification no. 7/33/2015-4TE2/5230/9/4 dated 30-06-2015 with effect from 01-07-2015. Therefore, the above mentioned document has no legal validity. The Punjab Govt. Notification attached at Annexure-VIII from page no. 55 to 57.

It is extremely pertinent to point out that the applicant institute exercised autonomy and admitted 187 candidates against the sanctioned intake of 120 seats in B.Tech. (Mechanical) even before it was given approval of academic autonomy by IKGPTU, Jalandhar. Please note that the last date of admitting students as per Hon'ble Supreme Court guidelines is 15th August.

- The UGC guidelines regarding autonomous colleges clearly states that
 "The act and statutes of the university ought to be amended to
 provide for the grant of autonomy to affiliated colleges." But, the PTU
 and the institute, SBSSTC, Ferozepur have been providing all kinds of
 arguments to circumvent the UGC guidelines. (Annexure-IX from page
 no. 58 to 61).
- 6. The Director, SBSSTC, Ferozepur has levelled serious assertions against MRSSTU that its action is unjustified in abiding the UGC norms and regulations. He has not provided any document pertaining to the case despite repeated requests by MRSSTU. To add further, it is misusing the issue of the grant of 5 crores under TEQIP as an excuse to bypass the guidelines of UGC and the University Act.The concerned letters of Director, SBSSTC are attached at (Annexure-X from page no. 62 to 65).
- 7. It is further added that despite many requests and advise rendered by MRSSTU (Annexure-XI from page no. 66 to 68) to the Director, SBSSTC, Ferozepur to cooperate in completing the required formalities, the applicant institute has assumed itself as autonomous and unilaterally amended the syllabi of its courses. The applicant institution has also decided to hold the examinations of various courses on its own, at the risk of the career and future of its students. (Annexure-XII from page no. 69 to 72).

The institution, SBSSTC, Ferozepur has failed to provide the relevant documents despite repeated requests.

Matter is placed before the Board of Governors for its consideration, and issue of necessary directions on the issue.

ITEM No. 3.4 TRANSFER OF EMPLOYEES.

The item was placed before the Board of Governors of Maharaja Ranjit Singh State Technical University, Bathinda in its 1st meeting held on 15.06.2015 vide item no. 1.9 and again was placed in its 2nd meeting held on 07.09.2015 vide item no. 2.5.

A meeting of both the Vice Chancellors of MRSSTU, Bathinda and IKG PTU, Jalandhar was held on 08.10.2015.

ITEM No. 3.5 CONFIRMATION OF THE PROCEEDINGS OF 2nd MEETING OF BUILDING WORKS COMMITTEE OF MRSSTU, BATHINDA.

2nd meeting of Building Works Committee of Maharaja Ranjit Singh State Technical University, Bathinda was held on 12.10.2015 under the Chairmanship of Vice Chancellor, MRSSTU, Bathinda. The proceedings of this meeting are placed at **Annexure-XIII from page no.73 to 74.**

ITEM No. 3.6 DELEGATION OF POWERS TO THE UNIVERSITY OFFICERS.

The item was placed before Board of Governors of Maharaja Ranjit Singh State Technical University, Bathinda in its 1st meeting held on 15.06.2015 vide item no. 1.17 and again was placed in its 2nd meeting held on 07.09.2015 vide item no. 2.11.

The Board deferred the item in its 2nd meeting and decided that the item be put up in the next meeting of Board of Governors. Thus a revised proposal based on the rules as proposed in the draft of rules/regulations/ordinances submitted to Govt. of Punjab by IKG – Punjab Technical University, Jalandhar in reference to delegation of financial and administrative powers has been drafted and placed at **Annexure-XIV from page no. 75 to 99.**

In the light of the above an annual grant of Rs. Five Crores for Maharaja Ranjit Singh State Technical University, Bathinda may be provided by the Punjab Govt.

ITEM No. 3.9 REGULATIONS FOR THE ACADEMIC PROGRAMME LEADING TO AWARD OF Ph.D DEGREE.

Maharaja Ranjit Singh State Technical University, Bathinda has been established as an affiliating University vide Punjab Act No. 5 of 2015 notified through Punjab Government Gazette-Extraordinary (Regd. No. CHD/0092/2015-2017) notification No. 5-Leg./2015 dated 12th February 2015.

To provide, upgrade and promote higher level research in technical education, MRSSTU, Bathinda shall offer academic programmes leading to the award of PhD degree through its Departments and approved research centres installed in its constituents/affiliated colleges and approved collaborative units. The proposed PhD regulations have been prepared taking into consideration all the provisions contained in UGC (Minimum Standards and Procedure for Award of M.Phil/Ph.D Degree) Regulations, 2009. The degree of doctor of philosophy (PhD) of the Maharaja Ranjit Singh State Technical University, Bathinda shall be conferred on a candidate who has carried on research under conditions prescribed by these PhD regulations.

The proposed PhD regulations of the University have been discussed in the meeting of Deans of Faculties of the University held on 04.10.2015 under the Chairmanship of Vice Chancellor (Revised proposal of Ph.D. regulations shall be circulated on the table).

TRANSFER OF REGISTRATION OF Ph.D STUDENTS FROM IKG PTU, JALANDHAR TO MRSSTU, BATHINDA.

The item was placed before Board of Governors of Maharaja Ranjit Singh State Technical University, Bathinda in its 2nd meeting held on 07.09.2015 vide item no. 2.27.

The Board decided that Principal Secretary, Technical Education & Industrial Training Pb., will convene a meeting of both the Vice Chancellors and Registrars of IKG PTU, Jalandhar and MRSSTU, Bathinda and the issue be resolved before the next meeting of Board of Governors alongwith other issues arising from time to time.

A meeting of both the Vice Chancellors of MRSSTU, Bathinda and IKG PTU, Jalandhar was held on 08.10.2015 and matter was discussed. The proceedings of the meeting shall be put up to the Board of table.

The University intends to start of new courses in the University Main Campus as well as in its constituent colleges like PIT(s) and Giani Zail Singh Campus College of Engineering & Technology, Bathinda in addition to the courses already running in the constituent colleges of the University. To discuss about the same, a meeting of all the Deans of Faculties and Directors of Constituent College/Institutes is being scheduled to be held on 04.11.2015. The detailed information to start the new courses will be circulated to the Board on table.
