Issues discussed in BOC Meeting are as under -

- New Study scheme of B.Sc. Non-Medical and Syllabus of 1st year was discussed. The board approval the same
 with the suggestion for exploring the possibility of inclusion of Punjabi language in the study scheme & syllabus.
 The matter of multiple exit levels for B.Sc. (Non-Medical) was also discussed in light of New Education Policy.
 The Board is of the view that multiple exit levels are not possible in B.Sc. (Non-Medical).
- Teaching load of Chemistry Department and subject allocation to the teachers for even semester 2022 was placed for approval and was approved.
- In view of significantly less admissions for past few years, it was propose to reduce the intake of B.Sc. (Hons)
 Chemistry & M.Sc. Chemistry to 30 seats for each class. The proposal was approved.
- The syllabus of bridge course (for candidates with non-science back ground in B.Tech) was also discussed and approved.
- 5. Revised CO's for B.Sc. (Hons). Chemistry and M.Sc. Chemistry were discussed and approved.
- The matter of eligibility for admission in B.Sc. (Hons) Chemistry & M.Sc. Chemistry was discussed and it was suggested that candidates having "equivalent" education should be given opportunity of admission. The members gave approval for this and recommended the revision of eligibility for taking admission in UG and PG courses of department.
- Discrepancy in passing CGPA and CGPA required to quality for degree was discussed. The board is of the opinion that all candidates who earn passing CGPA should be eligible to get degree in relevant course.
- In view of online classes due to Corona situation, it is decided that supervisor of M.Sc. Students can plan their project work accordingly.

Assigning the duty of program admission coordinators for each program was discussed and approved.
