- PET examination Fee of Rs 2000/- (for SC/ST candidates Rs 1000/-) should be deposited in any branch of Central Bank of India upto 21.12.2018. Date of Challan, date of payment and copy of paid challan should be uploaded on the user account.
- 6. Within 48 hrs of fee deposition, candidate's online PET form will be available for filling up along with uploading of photo and signature.
- 7. PET form is to be filled up ONLINE after registration and fee deposition.
- 8. The last date of online form filling complete in all respects is 24.12.2018. No separate hard-copy is to be sent. After successful submission of PET form candidate shall be intimated electronically automatically.
- 9. Admit card for the eligible candidates shall be available in their login ID on 27.12.2018.
- 10. All correspondence shall be made on the e-mail id/mobile number given by the candidate in the application form, so the candidates should be very careful in giving these details.
