GENERAL GUIDELINES

- 1. This Bridge championship being the inaugural under AIU, each University can send entries for up to **two teams**. The second entry from the same university shall be accepted if the number of competing teams is less than 20 and the same shall be intimated to you once we receive all the entries by the time stipulated below.
- 2. You are requested to send your consent of participation and also the number of teams you plan to send (maximum 2), to this office by regd./ speed post/ email on or before 15th February 2019.
- 3. The last date to receive detailed entry (only hard copies accepted) is on or before 25th February 2019.
- 4. All the teams should report at the venue one day prior to the commencement of the championship.
- 5. The players/ coaches/ managers coming for participation in this Inter University championship will be provided accommodation on campus.
- 6. The competition will be conducted as per the latest rules of the concerned federation (Bridge Federation of India).
- 7. Meeting of the managers/ coaches of the teams will be held on 7th March 2019 at 4:00 pm at the Indoor Sports Complex Shiv Nadar University. Checking/ submission of eligibility Performa etc. will start at 9:00 am at the venue on 7th March 2019.
- 8. The organizing committee shall reserve the right to change date, time and order of the matches etc., to be played as per situation, if and when necessary. The decision of the organizing committee shall be final and binding.

- 9. The team managers are required to submit <u>four copies</u> of the eligibility Performa duly typed and signed by the competent authority of the university as per AIU rules. Incomplete Performa will not be entertained. No over writing is permitted on the performa unless attested by the competent authority of their university.
- 10. Players must bring with them their identity cards of the current session duly signed by the director sports/ sports officer/registrar of the concerned university.
- 11. Team managers will be fully responsible for their players to maintain discipline at the venue of the tournament.
- 12. Teams are requested to report at the venue <u>fifteen minutes</u> before the start of first match/session. Detailed schedule for subsequent sessions/matches will be posted at the venue and teams are required to report 10 minutes before each session/match.
- 13. All expenses on local transport shall be borne by the participating universities

ELIGIBILITY INSTRUCTIONS

- 1. The revised eligibility rules will be followed in this championship (also available on the AIU website).

The participating university should submit attested photocopies of DOB proof, DMC of 10+2 class in case of the player is studying in under graduate course and that of 10+2 and graduation if the player is studying in post graduate without this the players will not be allowed to participate in the competition.
