OFFICE ORDER

Sub.: Regarding Seat surrender cases.

To streamline the fee refund of seat surrendered cases for the students admitted during MRSPTU admission 2020-21 in University main campus, it is decided that the concerned Deptt shall send compiled up cases in phases to the o/o DAA in a properly tagged file along with the verified summary sheet as per the attached format (Annexure-I,II). To avoid any refund related problem, Deptts shall ensure that the information supplied is correct in all respects.

The o/o DR(A) shall compile information of all Deptts and keep a record of these before forwarding it to the o/o PIC(F) for further necessary action as per university fee refund rules. Further, DR(A) shall ensure that no University Roll No get issued in such cases. The o/o PIC(F) shall ensure timely refund (not more than 15 days) of the fees to the left-out students with intimation to concerned Deptt.
