


Memorandum of Understanding

between

Engineering Staff College of India (ESCI) Hyderabad, Telangana, India







The Memorandum of Understanding (MoU) is made on the 15 to day of June 2016 between Engineering Staff College of India hereinafter referred to as "ESCI" represented by its authorized officer, "Director" and Maharaja Ranjit Singh Punjab Technical University, Bathinda, herein after referred to as "MRSPTU"

ABOUT ESCI: A.

Engineering Staff College of India (ESCI) is a unique Institution set up in October, 1981 by the premier body of engineers, The Institution of Engineers (India).

ESCI is Autonomous Organ of The Institution of Engineers (India) incorporated with an avowed objective of conducting Continuing Professional Development Specific Training Programmes, Research & Development, Consultancy services and PG Diploma Programmes in Engineering, Technology and Management areas.

B. ABOUT MRSPTU:

Maharaja Ranjit Singh Punjab Technical University, Bathinda has been established by the State Government of Punjab vide Punjab Act no. 5 of 2015 and is registered with UGC under section 2(f) of the UGC Act of 1956. All the colleges imparting technical education and situated within the territorial jurisdiction of Bathinda, Barnala, Faridkot, Fatehgarh Sahib, Fazilka, Ferozepur, Mansa, Moga, Sri Muktsar Sahib. Patiela and Sangrur Districts of the State of Punjab are affiliated with the university.

C. SCOPE:

The Scope of the MoU are:

- To conduct Training Programmes in the areas of Engineering, Management, Technology and Science domains for MRSPTU and its constituent and affiliated colleges.
- ii) Conducting Special Training Programmes relating to Institution Development.

 Faculty Development, Student Development.
- Disseminating Information through collaborative Seminars at Hyderabad / Bathinda as mutually agreed.
- iv) To enable collaboration amongst ESCI, MRSPTU and IEI Centres to conduct programmes in diverse technology domains.
- v) To take up joint projects in research and technology development.
- vi) To facilitate student internship programmes and innovative projects at UG/PG/PhD levels.

A Project committee team consisting of two (2) members each from ESCI and MRSPTU would meet at least every semester to decide, formulate and implement joint programmes in various domains. Terms of partnership and techno-commercial conditions will be decided on project-to-project basis prior to initiation of such knowledge dissemination.

vii) To create a Nodal centre at MRSPTU for conceptualization and implementation of programmes of ESCI. Purpose of the Nodal centre is to facilitate proficiency and skill development of faculty and students of MRSPTU and its constituent and affiliated institutions in various areas of engineering, management, technology and science under the aegis of ESCI, Hyderabad

D. GENERAL TERMS & CONDITIONS:

- a) This MoU shall be effective from the date of affixture of signatures of the parties and will remain in force for a period of three(3) years.
- c) This MoU will be reviewed by the partnership committee members from time to time and may be amended with the consent of both the parties and thereafter confirmed in writing.
- d) The parties agree and acknowledge that no other rights are granted except as explicitly stated herein.
- e) Neither party shall transfer or assign its interests, obligations or rights in this agreement without the written consent of the parties, provided that such consent will not be unreasonably withheld.
- f) Neither party shall be liable by reason of failure or delay in the performance of its obligation under this MoU, if such failure or delay is caused by the acts of God, Strikes, Lockouts or any other causes beyond its control and without its fault or negligence on mutual agreement.
- g) Any other arrangements or activities or commitments shall be made on mutually agreed terms from time to time.
- h) No amendments to the MoU shall be valid unless executed in writing and signed by both the parties.

D. TENURE AND TERMINATION:

This Agreement shall commence from the date of agreement and shall continue in force for three (3) years until terminated by either party.
