ITEM NO. 6.3 Construction of Shed for vehicles made by Students under SAE collegiate club.

A request has been received from HOD, Mechanical Engg. Deptt. (copy of letter attached at Page No. 20 & 21) for Construction of Shed for Vehicles made by Students under SAE Collegiate Club at GZSCCET, Bathinda.

Accordingly, an estimate for Rs. 2,89,828/- has been framed for the work. (Copy placed at Annexure-B at Page No. 18 to 19). Work will be undertaken through e-tender.

ITEM NO. 6.4 Supply, Installation, Testing & Commissioning of VCB & ACB required at GZSCCET, Bathinda

Replacement of ACB & VCB is required due to old ACB & VCB being out of order at Sub-Station. The quotation has been taken from two firms for ACB & VCB (copy attached at Page No. 25 to 30) & other items are CSR based.

Accordingly, an estimate for Rs. 26,00,089/- has been framed for the work. (Copy placed at Annexure-C at Page No. 22 to 24). Work will be undertaken through e-tender.

ITEM NO. 6.5 Regarding purchase of Electrical Items for Labs in PIT GTB Garh Moga

A request has been received from Assistant Registrar, PIT, GTB Garh, Moga (copy of letter attached at Page No. 35) for Electrical Items required for PIT, GTB Garh, Moga.

Accordingly, an estimate for Rs. 6,19,987/- has been framed for carrying out the above purchase through e-tender. (Copy of estimate placed at Annexure-D at Page No. 31 to 34).

ITEM NO. 6.6 Renovation in the Offices of HOD Mech & TPO

A request has been received from HOD, Mechanical Engg. Deptt. and Training & Placement Officer (copy of letters attached at Page No. 37 to 40) for renovation in the Offices of HOD Mech & TPO.

Accordingly, an estimate for Rs. 5,03,996/- has been framed for carrying out the above work through e-tender. (Copy of estimate placed at Annexure-E at Page No. 36).

ITEM NO. 6.7 Aluminium partitioning in Exam Branch, HOD & Research Lab of Computer Application Deptt.

A request has been received from Controller of Examination, HOD & Research Lab of Computer Application Deptt (copy of letters attached at Page No. 43 to 49) for Aluminium partitioning in Exam Branch, HOD & Research Lab of Computer Application Dept. for carving out extra space for offices etc.

Accordingly, an estimate for Rs. 12,77,414/- has been framed for carrying out the above work through e-tender. (Copy of estimate placed at Annexure-F at Page No. 41 to 42).

ITEM NO. 6.8 Construction of S & S Tank & Inlet Channel and its Boundary Wall at Giani Zail Singh Campus College of Engg. & Tech., Bathinda

The Canal Water is being supplied to the Municipal Corporation, Bathinda and Meritorious School, Bathinda too apart from the Giani Zail Singh Campus College of Engg. & Tech., Bathinda. The water is required for the University buildings too, so the existing storage of raw water is insufficient and an additional S & S Tank and Inlet Channel alongwith Boundary Wall is required.

Accordingly, an estimate for Rs. 75,93,648/- has been framed for carrying out the above work through e-tender. (Copy of estimate placed at Annexure-G at Page No. 50 to 59).

ITEM NO. 6.9 Regarding enhancement of amount for carrying out the petty works from Rs. 2.00 Lacs to 5.00 Lacs.

At present the limit for carrying out the petty works (Civil, Public Health & Electrical works etc.) by Calling Quotation is Rs. 2.00 Lacs, but it is very difficult to carry out the petty works below Rs. 5.00 Lacs through e-tender as such type of works often get delayed due to the e-tendering process.

The procedure for such works below Rs. 5.00 Lacs has been obtained from Punjab Agricultural University, Ludhiana, where the petty works upto Rs. 5.00 Lacs are carried out through quotations (copy enclosed at Page No. 60 to 68).

Matter is placed before the Building Works Committee for consideration and enhancement of the amount of e-tender from Rs. 2.00 Lacs to Rs. 5.00 Lacs please.
