AGENDA ITEMS

Item No. 12.1 Provision of Elevators in University, buildings.

Elevators to be provided were not taken in DNIT. As per the current decisions, separate BOQ amounting to Rs. 2,30,56,000/- for providing, installation, testing & commissioning of 13 passenger elevators has been provided by the Consultancy Wing, GNDU, Amritsar (copy attached at Annexure-A page no. 22 to 28). The Building Works Committee examined the case and recommended to proceed the work. The matter of Administrative and Financial approval is under process.

The matter is placed before the Committee for consideration and approval to float the e-tender for the above said work.

Item No. 12.2 Requirement of Electrical Load (2500 KW) for new Constructed buildings of MRSPTU, Bathinda.

Keeping the view new construction of buildings electrical load is to be applied to Punjab State Power Corporation Limited. An estimated cost of Rs. 41,55,900/- (Approx.) is likely to be incurred on the above work. The Building Works Committee examined the case and recommended to proceed with the work.

The matter is placed before the Committee for consideration and approval.

Item No. 12.3 Re-Construction of Toilet Blocks in Boys Hostel No. 1 & 2 (Total 03 Toilet Blocks).

The toilet blocks in the Boys Hostel No. 1 & 2 are un-safe and 01 block has been closed for use by students as major cracks have developed due to settlement as GI Pipes have leaked at many places. An estimate of Rs. 1,38,25,452/- had been prepared for the re-construction of the toilet blocks.

The Building Works Committee decided to construct one toilet block for the time being and recommended to proceed the work for one toilet block at a cost of Rs. 46,08,124/- (Copy of estimate placed at Annexure-B at Page No. 29 to 45). The matter of Administrative and Financial approval is under process.

The matter is placed before the Committee for consideration and approval to float the e-tender for the above said work.

Item No. 12.4 Construction of C.C Water tanks on top floor of Girls Hostel No. 02.

The Warden of Girl's Hostel No. 02 has requested that the existing PVC tanks are to be replaced with C.C. tanks as the water gets very hot during the summer season. An estimate of Rs. 5,51,310/- had been prepared for the construction of the tanks keeping in view the ease of students.

This matter was discussed with the University Administration and it was proposed that triple layer PVC tanks may be provided instead of RCC. So, the cost of PVC tanks would be approx. Rs. 05 Lacs.

The Building Works Committee decided that the damaged PVC tanks shall be replaced and possibility of covering PVC tanks with slab/sheet may be studied. The additional cost involved be worked out and process be initiated accordingly after reducing the cost of old broken tanks and the estimate is prepared for Rs. 5,41,289/- (Copy of estimate placed at Annexure-C at Page No. 46 & 47) & recommended to proceed with the work. The matter of Administrative and Financial approval is under process.

The matter is placed before the Committee for consideration and approval to float the e-tender for the above said work.

Raising of Back Side Boundary Wall near Workshop Block, Barbed Wire Fencing (7 Straight 2 Diagonal) on Boundary Wall & renovation of old rooms for Canteen with Electrical work at PIT, Rajpura District Patiala.

Some urgent works as raising of boundary wall near workshop block, Barbed wire fencing are to be carried out at PIT Rajpura as per letter received from Director, PIT Rajpura keeping in view the safety of

equipments. There is no canteen in PIT Rajpura, so a temporary room is to be renovated for canteen alongwith a temporary shed of GI Sheets for seating of students. An estimate of Rs. 4,71,113/- has been prepared for the above works (Copy placed at Annexure-D at Page No. 48 to 52). The Building Works Committee examined the case and recommended to proceed with the work by inviting e-tender.

The matter is placed before the Committee for consideration and approval to float the e-tender for the above said work.

Item No. 12.6 Renovation/ Maintenance for the various works at PIT, GTB Garh District Moga.

Some repair/renovation of houses is required at PIT GTB Garh to make them useable and also minor works as False Ceiling, Main entrance gate, Parking area, Painting/Whitewash, Boundary wall, Repair & Maintenance, Pathway to Block-B, Foundations of Machines in various labs, developments of a room as Seminar room, Window Glazing, Partitions in Lecture halls etc. is to be carried out. An estimate of Rs. 54,43,324/- had been prepared for the above works.

The Building Works Committee approved this work subject to the condition that flooring will not be changed and false ceiling shall be provided on minimum area to minimize the cost. Partitioning shall be made with aluminium glazing. Accordingly the revised estimate is being put up for Rs. 46,28,322/- (Copy of estimate placed at Annexure-E at Page No. 53 to 69) subject to the Administrative and Financial approval.

The matter is placed before the Committee for consideration and approval to float the e-tender for the above said work.

Item No. 12.7 Replacement of Grit Wash with Cement Plaster with grooves in Girls Hostel No. 1.

The Grit Wash provided in the Girls Hostel is very old and is coming off at various places which can cause harm to the students. The Warden, Girls Hostel has requested that the Grit wash be replaced with cement plaster. An estimate of Rs. 15,42,894/- had been prepared for the above work.

The Building Works Committee approved subject to the condition that this work shall be carried out only in the internal circulation area and the front side, so that the cost shall be reduced and recommended to proceed with the work by inviting e-tender. Accordingly the revised estimate is prepared for Rs. 8,40,946/- (Copy of estimate placed at Annexure-F at Page No. 70) subject to the Administrative and Financial approval.

The matter is placed before the Committee for consideration and approval to float the e-tender for the above said work.

Item No. 12.8 Renovation of Toilets of Girls Hostel No. 1 in the Campus.

The toilets of Girls Hostel No. 01 are to be renovated as rusted GI Pipes are to be replaced and floor and wall tiles are to be replaced. An estimate of Rs. 38,44,809/- has been prepared for the above work (Copy of estimate placed at Annexure-G at Page No. 71 to 80). The Building Works Committee examined the case and recommended to proceed with the work by inviting e-tender. The matter of Administrative and Financial approval is under process.

The matter is placed before the Committee for consideration and approval to float the e-tender for the above said work.

Item No. 12.9 Construction of a Workshop Shed for workshop at PIT Rajpura.

There is a requirement of shed for workshop at PIT Rajpura as classes have already started. The shed is proposed to be constructed in front of the already existing workshop block or it can be constructed at a suitable location after discussion with the Architect, but there would be no change in project cost due to this. An estimate of Rs. 42,88,053/- had been prepared for the above work. The Building Works Committee examined the case and recommended to proceed with the work by inviting e-tender. The revised estimate for Rs. 42,61,488/- (Copy of estimate placed at Annexure-H at Page No. 81 to 91) is prepared subject to the Administrative and Financial approval.

The matter is placed before the Committee for consideration and approval to float the e-tender for the above said work.

Item No. 12.10 Providing, Fixing & Commissioning of IP Based HD CCTV Camera's in various labs & Class rooms of PIT, Nandgarh, Bathinda.

Keeping in view of safety purpose, camera's required at PIT, Nandgarh as per requirement from the Director, PIT, Nandgarh. An estimate of Rs. 4,36,860/- had been prepared for the above work.

The Building Works Committee approved subject to the condition of the revision of cost by removing optical fiber cable and recommended to proceed with the work by inviting e-tender. Accordingly the revised estimate is prepared for Rs. 2,28,600/- (Copy of estimate placed at Annexure-I at Page No. 92) subject to the Administrative and Financial approval.

The matter is placed before the Committee for consideration and approval to float the e-tender for the above said work.

Item No. 12.11 Providing, Fixing & Commissioning of IP Based HD CCTV Camera's in PIT, GTB Garh, Moga & PIT, Rajpura.

Keeping in view of safety purpose, camera's required at PIT, Rajpura as per requirement from the Director, PIT, Rajpura & PIT, GTB Garh Moga. An estimate of Rs. 9,84,356/- had been prepared for the above work.

The Building Works Committee approved subject to the condition of the revision of cost by removing optical fiber cable and recommended to proceed with the work by inviting e-tender. Accordingly the revised estimate is prepared for Rs. 4,57,200/- (Copy of estimate placed at Annexure-J at Page No. 93) subject to the Administrative and Financial approval.

The matter is placed before the Committee for consideration and approval to float the e-tender for the above said work.

Item No. 12.12 Providing, Fixing & Commissioning of IP Based HD CCTV Camera's in GZSCCET, Bathinda.

Keeping in view of safety purpose, camera's required at GZSCCET, Bathinda as per requirement from Dean Academic &

directions of the Campus Director, GZSCCET, Bathinda. An estimate of Rs. 10,61,162/- had been prepared for the above work.

The Building Works Committee approved subject to the condition of the revision of cost by removing optical fiber cable and recommended to proceed with the work by inviting e-tender. Accordingly the revised estimate is prepared for Rs. 4,35,300/- (Copy of estimate placed at Annexure-K at Page No. 94) subject to the Administrative and Financial approval.

The matter is placed before the Committee for consideration and approval to float the e-tender for the above said work.

Item No. 12.13 Providing, Fixing, Commissioning & Testing of Bio Metric Attendance System at PIT, GTB Garh (Moga) (Warranty for One Year and AMC for Two Years).

As per discussion with higher Authorities, it was decided to install Bio Metric Machines at PIT, GTB Garh Moga to maintain the present strength of students as per requirement from the Director, PIT, GTB Garh Moga. An estimate of Rs. 2,17,120/- had been prepared for the above work.

The Building Works Committee decided to install two number of machines at GTB Garh Moga and the cost shall be worked out accordingly and recommended to proceed with the work. Accordingly the revised estimate is prepared for Rs. 1,08,560/- (Copy of estimate placed at Annexure-L at Page No. 95 to 96) subject to the Administrative and Financial approval.

The matter is placed before the Committee for consideration and approval.

Item No. 12.14 Providing, Fixing, Commissioning & Testing of Bio Metric Attendance System at PIT, Rajpura (Warranty for One Year and AMC for Two Years).

As per discussion with higher Authorities, it has been decided to install Bio Metric Machines at PIT, Rajpura to maintain the present

strength of students as per requirement from the Director, PIT, Rajpura. An estimate of Rs. 2,17,120/- had been prepared for the above work.

The Building Works Committee decided to install two number of machines in Campus and the cost shall be worked out accordingly and recommended to proceed with the work. Accordingly the revised estimate is prepared for Rs. 1,08,560/- (Copy of estimate placed at Annexure-M at Page No. 97 to 98) subject to the Administrative and Financial approval.

The matter is placed before the Committee for consideration and approval.

Item No. 12.15

Providing, Fixing, Commissioning & Testing of Bio Metric Attendance System at PIT, Nandgarh (Warranty for One Year and AMC for Two Years).

As per discussion with higher Authorities, it has been decided to install Bio Metric Machines at PIT, Nandgarh to maintain the present strength of students as per requirement from the Director, PIT, Nandgarh. An estimate of Rs. 1,62,840/- had been prepared for the above work.

The Building Works Committee decided to install two number of machines in Campus and the cost shall be worked out accordingly and recommended to proceed with the work. Accordingly the revised estimate is prepared for Rs. 1,08,560/- (Copy of estimate placed at Annexure-N at Page No. 99 to 100) subject to the Administrative and Financial approval.

The matter is placed before the Committee for consideration and approval.

Item No. 12.16

Supply, Installation, Testing & Commissioning of DG Set 160 kVA at PIT, Nandgarh.

As per requirement from the Director, PIT, Nandgarh for uninterrupted power supply. An estimate of Rs. 13,08,060/- had been prepared for the above work.

The Building Works Committee decided to install 125 kVA DG Set instead of 160 kVA DG Set and the cost shall be worked out accordingly and recommended to proceed with the work by inviting e-tender. Accordingly

the revised estimate is prepared for Rs. 9,78,616/- (Copy of estimate placed at Annexure-O at Page No. 101 to 107) subject to the Administrative and Financial approval.

The matter is placed before the Committee for consideration and approval.

Item No. 12.17 Construction of Gate and Check Post at Aeronautical Engineering College at Patiala.

A new Aeronautical College Building has been constructed at Patiala. Now, construction & maintenance works of the above college are to be executed by MRSPTU, Bathinda. On demand of the College Administration, drawings for the construction of Gate and Check Post were prepared by the Architecture Department of the University which were received in this Office vide letter no. Arch/D/18/675 dt. 24/08/2018. An estimate for Rs. 8,06,463/- has been prepared for the above work (Copy of estimate placed at Annexure-P at Page No. 108 to 114). The Building Works Committee examined the case and recommended to proceed with the work by inviting e-tender. The matter of Administrative and Financial approval is under process.

The matter is placed before the Committee for consideration and approval.

Item No. 12.18 Installation of solar power plant on roof tops at GZSCCET, Bathinda.

Solar Power Plant is to be installed on the roof tops of GZSCCET, Bathinda through RESCO Mode. Previous agreements have been obtained from the following Governments Institutions who have signed agreement for Solar Power Plant.

- 1. Punjab Agriculture University, Ludhiana Capacity 1 MW
- 2. Guru Nanak Dev University, Amritsar Capacity 1 MW
- 3. Zails in Punjab Capacity 5 MW

The Above Institutions have signed agreement in RESCO Mode and after going through the agreement, the following observations are made:-

- 1. The companies approved by Solar Energy Corporation of India Ltd. install the Solar Power Plant and power is charged @ Rs. 3.32 paisa/per Unit and this tariff is applicable for 25 Years.
- 2. The concerned institute signs the agreement for 25 years for installation of Solar Power Plant.
- 3. The company will be responsible for the repair, look after of Solar Power Plant for the period of 25 years and institute will not make any payment toward the above cost.
- 4. The institute shall provide points for water supply for the cleaning of solar panels.
- 5. The institute shall arrange to cut/trim the trees if they give shade to the solar panels.

After going through the above agreement, it has been observed that Azure Power Rooftop One Pvt. Ltd. has installed all the above solar plants in the Education Institutions.

It is also worth mentioning that if solar plant is got installed through RESCO Mode, then the institute will save approximately Rs. 17 Crore in 25 Years (copy attached at Annexure-Q page no. 115).

The last date of commissioning of Solar Power Plant through RESCO Mode is 20-10-2018 as given by the Solar Energy Corporation of India Ltd. to the above company and the last date for signing of agreement with Azure Power Rooftop One Pvt. Ltd. was 08-09-2018. So, accordingly the agreement was made with the above company (copy attached at Annexure-Q page no. 116 to 157). The Building Works Committee examined the case and approved the same.

The matter is placed before the Committee for information.

Two tenders of the firms M/s Subhash Mittal Printing Press, Bathinda & M/s J.R. Printing Press, Sangrur have been received, which were sent to Chairman, Evaluation Committee for Technical Evaluation vide letter Ref. No. MRSPTU/Purchase/18-19/354 dated 04-9-18.

On the same day i.e. on 04-9-18 Mr. Sanjay Rajpal of M/s Between Lines sent a mail to Controller, Examination informing him that party from Sangrur is already a blacklisted party and COE forwarded the mail of the firm to Registrar, MRSPTU & drspbti@rediffmail.com with the remarks to look into the matter.

On dated 07-9-18 firm was asked to provide documentary proof regarding blacklisting of Sangrur firm and also provide contact number and complete address of his firm, so that further necessary action may be taken accordingly, and the firm provided a copy of letter issued by Secretary Punjab Mandi Board, SAS Nagar, Mohali vide Ref No. E PROVIDED 18/874-1029 FIRST 27-8-18 addressed to all Secretaries Market Committee, Punjab regarding blacklisting of firm M/s J.R. Printing Press, Nabha Gate, Sangrur. After receiving the letter it is found that firm has been blacklisted on dated 27-08-2018 and also last date of closing of tender was 27-08-2018 (copy attached at Annexure-X Page No. 204 to 207).

Evaluation committee raised some observation while evaluationing the bids, accordingly firm were asked vide letter Ref. No. MRSPTU/Purchase/18-19/861 & 862 dated 21-9-18 to comply the same. Both the firm have provided required clarification and firm M/s J.R. Printing Press, Sangrur vide their letter Ref. After technical evaluation and recommendation of committee price bid of both the firms have been opened. Rate quoted by firm M/s J.R. Printing Press, Sangrur is Rs. 2,41,51,680/- (including tax @ 12%) and M/s Subhash Mittal Printing Press, Bathinda is Rs. 2,29,82,400/- (including tax @ 12%) and this firm also given a note in price bid that

"Rate for one year (financial year 2018-19)= Rs. 9.40+ GST". Same has been sent to evaluation committee for recommendation.

As per recommendation given by the evaluation committee order may be issued to M/s Subhash Mittal Printing Press, Bathinda as per terms & conditions of the tender, but it was not clear that order for one year qty. or 3 year qty. will be given. Also nothing has been mentioned on the rates given by this firm for one year (financial year 2018-19).

It is hereby informed that there is a difference of Rs. 76,82,400/-, as the actual cost of 18 Lac answer sheets in the tender received is Rs. 2,29,82,400/- whereas approximate sanctioned amount was Rs. 1,53,00,000/-.

Further it is also to be noted that if the one year qty. i.e. 6 lakh answer sheets are to be printed on the basis of rate given by the firm for one year (financial year 2018-19)= Rs. 9.40+GST 12% extra then total cost will be Rs. 56,40,000/-+ GST extra.
