Item No. 6.1

Floating of E-Tender for the Procurement of Fourier Transfer Infrared (FTIR) Spectrophotometer with Attenuated Total Reflectance (ATR) attachment for Applied Chemistry Deptt. The approximate cost of the equipment is Rs. 22.00 Lac.

To improve the research facility in the department of Applied Science the department of Applied Chemistry has raised a demand for the purchase of FTIR Spectrophotometer with ATR attachment. The equipment will be Central Facility for other departments viz: Science departments, Environment Science, Pharmaceutical The Vice-Chancellor has given the financial sanction vide No. 333 dated 29.03.2016 (Annexure –I at page No.1 to 1) for the purchase of the equipment The technical specification of the equipment as recommended by the Committee of experts are placed at Annexure – II at page No. 2 to 3. The approximate cost of the equipment is Rs. 22.00 Lacs. Keeping in view the demand of the equipment the procurement is to be done by E-Tendering as per the purchase rules.

The matter is placed before the committee for consideration and approval to float the e-tender for the procurement of the equipment.

Requirement of Stationary Items for MRSPTU, Bathinda and GZSCCET, Bathinda. Approximate cost is Rs. 2,62,200. These items are required for the routine office work by the various departments joint demand has been raised.

Item No. 6.5

The building drawings of the University have been prepared by the Department of Architecture GNDU, Amritsar who have been appointed as consultants for the University.

The buildings of the Main Campus of the University are to be constructed in a phased manner. The first phase of the construction of the Buildings of the University is to be started for which the technical vetting of the estimates amounting to Rs. 128.78 Crores without taxes and with taxes & cesses the amount would be Rs. 136.69 Crores has been got done from the Technical Advisor to the Hon'ble Chief Minister Punjab (copy at Annexure - IX from page No. 11 to 13). The technical sanction of the estimates and the DNIT has been approved by the HOD, Civil Engineering department of GZSCCET, Bathinda, as authorized by the BOG in its 4th Meeting (copy placed at Annexure - X from page No. 14). The BOG has in this regard decided "The construction work shall be carried out under the supervision of the following committee from Giani Zail Singh Campus College of Engineering & Technology, Bathinda"
