### AGENDA ITEMS

Item No. 19.1 To confirm the minutes of 18th Tender Finalization Committee.

The 18th meeting of Tender Finalization Committee of Maharaja Ranjit Singh Punjab Technical University, Bathinda were held online (google meet) on 16-03-2022 respectively. The minutes were circulated to all the members via email vide ref. no. MRSPTU/Purchase/21-22/3039 dated 25-03-2022. No comments were received from any member of committee, so the minutes of 18th TFC is placed at (Annexure-I, Page No. 4-7).

Item No. 19.2 Providing & Fixing of Furniture & Fixture (for 14 Class Rooms with 63 seats in each classroom =882 seats) for Estate Deptt. of MRSPTU, Bathinda for Rs. 37.80 Lacs.

For the purchase of furniture & fixture (Class Room Furniture/Office Furniture etc.) for Estate Deptt., MRSPTU, Bathinda of Rs. 47.30 Lacs (Capital Grant) vide sanction on noting dated 28-02-2022 approved by Hon'ble Vice Chancellor for F.Y. 2021-22. The 18th TFC has already been cleared for purchase of this item. As per item no. 18.2 of Agenda items 'this purchase shall be done through GeM Portal as far as possible as per university regulations' and the same has been approved in item no. 18.2 of Minutes of Meeting. The purchase committee decided to purchase the items like Executive Tables (6), Revolving Chairs (6), Vising Chairs (12), Lecture Stand (14) & White/Green Board (14) through GeM Portal. The purchase of remaining furniture items i.e. class room furniture for 14 class rooms will be done through etendering process (which is not possible through GeM Portal) due to fixation according to site conditions and space in the class rooms in the university. The purchase department has received Sanction No. UNIV/2022-23/EST/000530 dated 06-07-2022 of Rs. 37.80/- Lacs from Estate Department, MRSPTU, Bathinda approved by the Hon'ble Vice Chancellor for the same. The detail of item is placed at (Annexure-II, Page No. 8 to 10).

The matter is placed before the Tender Finalization Committee for E-tendering approval.

Item No. 19.3

Regarding purchase of Stationery Items through Annual Rate Contract for MRSPTU & its Constituent Colleges (Amount Rs. 20.00 Lac)

Previous Rate Contract for purchase of Stationery Items for MRSPTU Bathinda & its various Constituent Colleges entered by the University with two firms namely M/s J.R. Printing Press, Sangrur and M/s Bahuchar Traders, Mumbai. The period of annual rate contract with both the firms has already been elapsed but only M/s Bahuchar Trader, Mumbai gave consent for more one year extension on the same previous quoted rates (Annexure-I Attached). A new e-tender for some stationery items is to be floated for the requirement of university. The Sanction No. UNIV/2022-23/ADM/000196 dated 14-07-2022 of Rs. 17,92,115/- Lacs from Store & Purchase Department, MRSPTU, Bathinda has been approved by the Hon'ble Vice Chancellor. The detail of items is placed at (Annexure-III, Page No. 11 to 13).

The matter is placed before the Tender Finalization Committee for E-tendering approval.

### Item No. 19.4

Regarding modification of tender documents (Annexure-IV Page No. 14 to 24).

4th Tender Finalization Committee, approved some decision under the head of 'other decision taken' for qualifying criteria for inviting bids. The same is as under below:-

- Technical negotiation should be carried out with the L-1 i.e. lowest evaluative responsive bidder only under exceptional circumstances as per GFR 2005 Rule 160 (xii).
- While inviting bids, following qualifying criteria as discussed be included for purchase of above said lab equipments/software/apparatus.
  - (i) Bidder having successfully delivered of similar goods/items of value 100% of the estimated value in the last three financial years.
  - (ii) Satisfactorily delivery of similar goods/items of value not less than 50% of estimated value as a single order in the last three financial years.
- Bidder having his own manufacturing unit or authorized dealership certificate.
- 4. Financial standing such as statement of profit and loss account, Balance Sheet, Auditor report for the last three years provided by the bidder and credit worthiness certificate form bank.
- Bidder having minimum financial turnover be 03 times to the estimated value during at least in last three financial years.

While evaluating the technical bid, technical evaluation committee has to face many issues for Sr. No.4 as mentioned above. The firms are unable to provide requisite documents to the university. As a result of this, many tenders get delayed and sometimes has to be cancelled due to lack of documents.

So it is proposed to amend Sr. No. 4 as mentioned below:-

- (a) Balance Sheet signed by CA for last three years.
- (b) ITR for the last three years.
