



18.2	Regarding Purchase of Various Items from the Sanctioned Capital Grant of Rs. 1.00 Crore by Govt.	<p>Approved.</p> <p>Regarding purchase of various items from Capital Grant, observations were given by nominee of Director, TE&IT, Chandigarh that if possible, this purchase may be executed from Jail Departments in Punjab. In this regard, Registrar MRSPTU, Bathinda conveyed that university approached jail departments in Ferozepur, Patiala, & Gurdaspur etc. for university requirements regarding furniture, but the Jail Departments of Ferozepur & Patiala are not manufacturing the furniture at present and at other places the furniture items prepared are not as per university requirement.</p>
18.3	Regarding purchase of Equipment & Furniture for setting up of Food Testing Laboratory sanctioned by MoFPI at Deptt. of Food Science & Technology of MRSPTU, Bathinda (Amounting Rs. 1,09,12,000/-).	<p>Approved.</p> <p>Regarding purchase of furniture from the university contribution, it was decided that if any amount left after spending on purchase of furniture from Capital Grant (Ref. Item No. 18.2), then remaining amount should be used for the furniture, otherwise approved to utilize from the university budget.</p>

General Observations:

As per university regulations (point 12.4), 'The TFC shall deal with all purchases/procurements and works of estimated value two lacs and above'. In regard to observations has been given by the nominee of Director, TE&IT, Chandigarh to define properly the mandate of TFC by constituting a committee and the same should be got approved from BoG. The matter related to same should be put up to higher authority.


