



Item No. 21.1 To confirm the minutes of 20th Tender Finalization Committee.

The 20th meeting of Tender Finalization Committee of Maharaja Ranjit Singh Punjab Technical University, Bathinda were held online (google meet) on 01-12-2022. The minutes were circulated to all the members via email vide ref. no. MRSPTU/Purchase/22-23/3275 dated 06-12-2022. No comments were received from any member of committee, so the minutes of 20th TFC is placed at (Annexure-I, Page No. 3 to 5).

Regarding approval for outsourced services (Security, Sweeping, Cleaning, Horticulture, Clerk, Drivers, Peon, Lab Attendant, Civil Works & Maintenance etc.) from PESCO (Govt. Organization).

A work order for two years was issued vide letter No: MRSPTU/Purchase/21-22/1612/1219 dated 03-04-2021 to the firm M/s City Hawk MPSC, New Delhi regarding the above mentioned services till 30-04-2023 through etender. As per the terms and conditions of the work order, the concerned firm can be given one year extension. An e-mail dated 07-02-2023 has been received from the in-charge, security wing regarding dissatisfaction with the work of the concerned contractor.

In view of the difficulties of the concerned employees, it is recommended to award the contract for the said services to Punjab Ex-Serviceman Corporation (PESCO) which is a Punjab Government Institution. These services are being operated by PESCO at DTE, Chandigarh and different Government Polytechnic Colleges in Punjab. According to Point No: 12.4 of Purchase Regulations Chapter-6 "The TFC shall deal with all purchases/procurement and works of estimated value/two lac and above". According to Point No:

12.1 of Purchase Regulation Chapter-6 "The purchase with estimated value of Rs. 2.00 Lac and above shall be made through e-tendering" and PESCO is a government organization and hence these services may not be e-tendered. It is recommended that the period of hiring outsourced services will be for 2 years and further extension of One year can be given after satisfactory report of service. A copy of the proposal sent by the PESCO regarding the said services is attached (Annexure-II at Page 06 to 14).

The matter is presented before the committee for consideration and approval to provide the outsourced services by PESCO (Govt. Organization).
