Consequent upon the approval of the competent authority vide no. VC/916 dated 20.06.2022 and further modification approved vide no. VC/979 dated 11/08/2022, the University is pleased to announce Chief Minister Scholarship for Session 2022-23 for University Main Campus, GZSCCET, PITs and PSAEC Patiala as per the detail mentioned below:

## Category I

## B. Tech.

- 1. Scholarship equivalent to 50% tuition fee will be provided to the candidates who have secured JEE rank less than 50,000.
- 2. Scholarship equivalent to full tuition fee will be provided to the respective university toppers in the qualifying examinations.
- 3. For University main campus, GZSCCET, Bathinda Scholarship equivalent to 50% tuition fee will be provided to the candidates who have secured more than 90% marks in qualifying examination.
- 4. For PITs, PSAEC Patiala Scholarship equivalent to 50% tuition fee will be provided to the candidates who have secured more than 80% marks in qualifying examination.

#### Category II

M. Tech and M. Pharm

Scholarship equivalent to full tuition fee will be provided to the respective university toppers in the qualifying examinations.

#### Category III

#### B. Arch

- (a) Scholarship equivalent to full tuition fee will be provided to the university/education board toppers in qualifying examinations.
- (b) Scholarship equivalent to 50% tuition fee will be provided to the candidates who have secured more than 90% marks in 10+2 (Non Medical)/10+3 diploma with Maths.

#### Category IV

M.Sc. (Chemistry/Physics/Mathematics/Food Science & Tech), MBA, MCA, M.Com and any other PG Courses

- 1. Scholarship equivalent to full tuition fee will be provided to the respective university toppers in the qualifying examinations.
- For University main campus, GZSCCET, Bathinda Scholarship equivalent to 50% tuition fee
  will be provided to the candidates who have secured more than 90% marks in qualifying
  examination.

3. For PITs, PSAEC Patiala - Scholarship equivalent to 50% tuition fee will be provided to the candidates who have secured more than 80% marks in qualifying examination.

## Category V

Any other UG, Integrated and Dual degree Courses offered

- 1. For University main campus, GZSCCET, Bathinda Scholarship equivalent to 50% tuition fee will be provided to the candidates who have secured more than 90% marks in qualifying examination.
- 2. For PITs, PSAEC Patiala Scholarship equivalent to 50% tuition fee will be provided to the candidates who have secured more than 80% marks in qualifying examination.
- 3. Scholarship equivalent to full tuition fee will be provided to the respective university toppers in the qualifying examinations.

# General Conditions for the continuation of the scholarship in higher semester

Visherara Rance Singh Ponteo Lecharcal University

- 1. For the continuation of the scholarship, the student must secure minimum 8 CGPA in each semester without any reappear in any semester.
- 2. A student can avail only one scholarship scheme at a time.
- 3. He/She must have shown good conduct throughout the session.
