The University is pleased to notify the fee refund rules on seat surrender for the **session 2025–26**, applicable to the **University Main Campus, GZSCCET, PITs, PSAEC Patiala, and all affiliated colleges**. For **AICTE / UA-AICTE / PCI / CoA programmes**, the rules are in accordance with the notifications issued by AICTE and DTE&IT, Punjab. For **UGC / Non-AICTE / Skill / PG Skill / PG Diploma / Diploma programmes**, the rules of the previous year shall continue, in line with point no. 3(e) of the UGC Notification D.O.No.F.2-71/2022 (CPP-II) C-114546 dated 12.06.2025, which states: “The policy will remain in force for subsequent academic sessions until the issuance of a revised policy by the UGC”, since no separate rules have been notified for the current session.

In the event of a student withdrawing before the start of the programme, the entire Fee collected from the student, after a deduction of the processing Fee of not more than Rs.1000/- (Rupees One Thousand only) shall be refunded. School/ Institution Leaving Certificates in original will be returned back to students.</li><li>2. In case, if a student leaves after joining the Course and if the vacated seat is consequently filled by another student by the last date of admission, the fee collected shall be refunded after a deduction of the processing fee of not more than Rs.1000/- (Rupees One Thousand only) and proportionate deductions of monthly Fee and hostel rent, where applicable.</li><li>3. In case the vacated seat is not filled, only the Security Deposit will be refunded and documents in original will be returned back.</li><li>4. No fee will be demanded for the subsequent years from the students cancelling their admission at any point of time.</li></ol> <p><b>The counselling fee of ₹3000 per student is non-refundable and is separate from the processing fee.</b></p>
