For UGC / Non-AICTE / Skill / PG Skill / PG Diploma / Diploma programmes, the rules of the previous year shall continue, in line with point no. 3(e) of the UGC Notification D.O.No.F.2-71/2022 (CPP-II) C-114546 dated 12.06.2025, which states: "The policy will remain in force for subsequent academic sessions until the issuance of a revised policy by the UGC", since no separate rules have been notified for the current session.
