The following decisions were taken in the meeting:

**ITEM NO. 24.1 REGARDING APPROVAL OF THE LEGAL ADVICE IN COCP 1578 of 2025 TITLED DR GURPRIT SINGH BATH V/S MS SHRUTI SINGH IAS AND OTHERS W.R.T. IMPLEMENTATION OF PENSION IN THE CASE PERTAINING TO CONVERSION OF CPF TO GPF.**

**DECISION:**

The agenda was discussed in detail and in view of the advice taken from Department of Finance, Govt of Punjab and Advocate General of Punjab, on the matter, it was decided that:

1. Circular No. Uni/Estb/3061 dated 26.10.2022 be hereby recalled, rescinded and scrapped with immediate effect.
2. Office Order No. 177/899 dated 17.04.2023 and Office Order No. Uni./Estb./28/53 dated 04.01.2024 be withdrawn and cancelled.
3. Any option exercised pursuant thereto shall stand annulled and shall not confer any vested or enforceable right.
4. All transfers made from CPF accounts to the Pension Fund shall be reversed and restored to respective CPF accounts.
5. All deficit amounts deposited/recovered from employees pursuant to the above circulars/orders shall be refunded in full along with interest strictly in accordance with Finance Department instructions dated 28.11.2025 and 10.12.2025 and as per applicable CPF Rules.
6. Retiral benefits of concerned employees shall be regulated strictly under CPF Rules and released expeditiously.
7. The board authorized the Vice Chancellor, MRSPTU, Bathinda to finalize detailed speaking order to be placed before the Hon'ble High Court in COCP No. 1578 of 2025 by the Registrar, MRSPTU, Bathinda to demonstrate bona fide compliance of order dated 11.12.2024.
