

## Paper Submission Guidelines

## Registration Guidelines

1. The full paper should include the following components:
  - Title of the paper
  - The author(s) name along with their institutional affiliation
  - Email-ID of the author(s)
  - Abstract (not exceeding 250 words)
  - Keywords (minimum 4–5)
  - Introduction
  - Literature Review
  - Methodology
  - Findings and Discussion
2. The complete manuscript should be between 2500 and 3500 words, inclusive of the title page, abstract, main text, tables, figures, graphs, and references.
3. The manuscript must be formatted on A4-size paper, using Times New Roman font (12 size) with 1.5 line spacing and 1-inch margins on all sides. Headings should be in bold with font size 12.
4. All tables, figures, and graphs should be inserted at appropriate places within the text and must be numbered sequentially, starting with Table I, Figure I, and Graph I, and so on.
5. References should strictly follow the APA (American Psychological Association) style guidelines.
6. Please note that the full paper must be submitted in PDF format only and sent via email mentioned below, strictly in accordance with the prescribed format.

1. All submitted papers will undergo a peer-review process. The acceptance of selected papers will be communicated to the respective authors after completion of the review.
2. Incomplete submissions or manuscripts that do not adhere to the prescribed format will not be considered for the review process.
3. Individuals who wish to attend the conference without presenting a paper may also participate by completing the registration process and paying the prescribed fee using the same payment details.
4. In the case of multiple-authored papers, certificates will be issued only to those author(s) who have registered for the conference and paid the registration fee.
5. Authors submitting more than one paper must pay the registration fee separately for each paper.
6. The registration fee is non-refundable once paid.
7. Upon acceptance of the paper, the author(s) are required to complete the conference registration through the conference registration link provided below.
