Subject: Introduction and Assessment Scheme for the Course "General Proficiency" for students admitted under UG programmes from Batch 2026 onwards for AICTE/UA-AICTE programmes offered at the University Main Campus, GZSCCET, PITs, PSAEC Patiala, and all affiliated colleges.

Consequent upon the approval of the competent authority vide diary no. VC/459 dated 20.07.2026, to promoting the holistic development of students and recognizing their overall participation, conduct, and contribution towards academic as well as co-curricular activities, the University has decided to introduce a course titled "**General Proficiency**" for students admitted under **UG programmes** in AICTE / UA-AICTE programmes from **Batch 2026 onwards**.

The recommendations of the Committee constituted for framing a uniform assessment and evaluation scheme were considered in its meeting held on **12 June 2026**, and the following decisions were approved for implementation:

1. Course Structure

1. The course "**General Proficiency**" shall carry **One (01) Credit** in every even semester and shall be **mandatory** for all eligible students admitted under AICTE/ UA-AICTE programmes from Batch 2026 onwards.
2. For all the other programmes not governed by AICTE, the inclusion of this course may be considered by the respective Board of Studies (BoS) in accordance with applicable academic regulations.
3. The course shall be evaluated **entirely through internal assessment** carrying **100 marks**. There shall be **no external examination**.

2. Assessment Scheme

The internal assessment of 100 marks shall be distributed as follows:

Component	Marks
General Behaviour, Discipline and Conduct	20
Participation in University/College Level Sports, Cultural, NSS and NCC Activities	40
Participation in Department-Level Co-curricular and Extra-curricular Activities	40
Total	100

3. General Behaviour (20 Marks)

The assessment of General Behaviour shall be carried out at the department level based on the student's discipline, conduct, punctuality, professional ethics, and overall behaviour during the academic year.

4. Sports, Cultural, NSS and NCC Activities (40 Marks)

1. Forty (40) marks shall be awarded for participation and achievements in Sports, Cultural, NSS and NCC activities organized at the College or University level.
2. The evaluation criteria have been prepared by the respective Coordinators/Director concerned, considering factors such as:

- Participation in events;
 - Positions/awards achieved;
 - Responsibilities undertaken during organization of events;
 - Overall contribution and involvement.
3. Participation certificates, appreciation certificates, awards, and other supporting documents shall be considered as documentary evidence.

5. Department-Level Co-curricular and Extra-curricular Activities (40 Marks)

1. Forty (40) marks shall be awarded based on participation in departmental activities, including but not limited to:
 - Technical, literary and cultural events;
 - Field visits and industrial tours;
 - Expert lectures;
 - Seminars, workshops and conferences;
 - Mock interviews and placement drives;
 - Departmental competitions and similar academic enrichment activities.
2. The department shall maintain proper records of student participation.

6. Assessment Procedure

1. A standardized **Evaluator Handbook** developed by the Committee for evaluating student participation and achievements is attached herewith (**Annexure –I**).
2. At the end of each **Even Semester**, every student shall submit the duly filled Assessment Proforma along with supporting documents for College/University-level activities to the concerned department (**Annexure –II**).
3. Documentary evidence for department-level activities shall be maintained by the concerned Class In-charge/Batch Advisor.
4. The Class In-charge/Batch Advisor or any faculty member nominated by the Head of the Department shall compile the marks for submission.

All Heads/Principal/Directors of Main Campus/Constituents/PITs/PSAEC/Affiliated Colleges of MRSPTU, Bathinda are requested to take necessary action for effective implementation of the above assessment scheme from the Academic Session **2026-27** onwards.

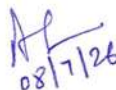

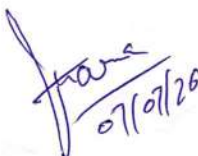

INTRODUCTION

The holistic development of students is a fundamental objective of higher education. These activities provide valuable opportunities for students to develop interpersonal skills, organizational abilities, civic responsibility, creativity, and professional ethics, thereby complementing their academic learning.

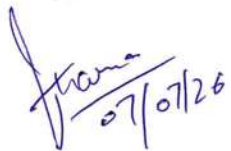
This handbook has been prepared to establish a transparent, fair, and uniform evaluation process across all departments and affiliated institutions of the University. It serves as a reference document for Mentors, Faculty Members, Departmental Coordinators, Sports Officers, NSS Programme Officers, NCC Officers, and Evaluation Committees responsible for assessing General Proficiency.

The evaluation process outlined in this handbook emphasizes evidence-based assessment. Marks shall be awarded only after verification of authentic documentary proof and in accordance with the approved evaluation criteria. Evaluators are expected to exercise impartiality, consistency, and academic integrity while assessing student achievements.

The objectives of this handbook are to:

- Provide standardized guidelines for the evaluation of General Proficiency.
- Ensure uniformity and transparency in the assessment process across all departments and institutions.
- Define the roles and responsibilities of evaluators and verification authorities.
- Establish clear criteria for awarding marks under various activity categories.
- Encourage active student participation in activities that contribute to their overall personality development and professional growth.

The General Proficiency score shall be calculated in accordance with the University-approved marking scheme and shall reflect a student's overall contribution beyond the classroom. Through this initiative, MRSPTU aims to nurture well-rounded graduates equipped with the knowledge, skills, values, and leadership qualities required to excel in their professional careers and contribute meaningfully to society.
