

1.	For Admission to AICTE/ UA-AICTE/ PCI / CoA programmes through Centralized / Direct Online Counselling	<p>The refund of fees on seat surrender shall be as per the AICTE/ DTE&IT, Punjab norms;</p> <ol style="list-style-type: none">1. In the event of a student withdrawing before the start of the programme, the entire Fee collected from the student, after a deduction of the processing Fee of not more than Rs.1000/- (Rupees One Thousand only) shall be refunded. School/ Institution Leaving Certificates will be returned.2. In case, if a student leaves after joining the programme and if the vacated seat is consequently filled by another student by the last date of admission, the full refund of the Fee collected after a deduction of the processing Fee of not more than Rs.1000/- (Rupees One Thousand only) and proportionate deductions of monthly Fee and hostel rent, where applicable.3. In case the vacated seat is not filled, the Security Deposit only will be refunded along with the original documents.4. The Fee for the subsequent years should not be taken from the students cancelling their admission at any point of time.5. The refund of Fee along with the Certificates should be completed within 7 days after receiving a written application form, prescribed by the University, by the student in this regard. <p>The counselling fee of ₹3000 per student is non-refundable.</p>

1. In case of (Sr. No. 1) in the table above, an amount not more than 5% of the fees paid by the student shall be deducted, subject to a maximum of Rs. 5,000/- as processing charges from the refundable security amount and University Counselling Fee.				
2. In case of (Sr. No. 2, 3, 4, 5) in the table above, the University Counselling Fee shall be non-refundable.				
3. Fees shall be refunded to an eligible student within 15 days from the date of receiving a written application form, prescribed by the University, by the student in this regard.
