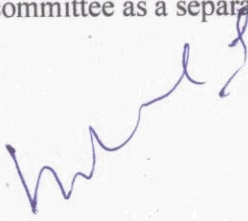
The following points were discussed in the meeting and the Minutes of Meeting are as under:

Decision: The matter was discussed and approved.

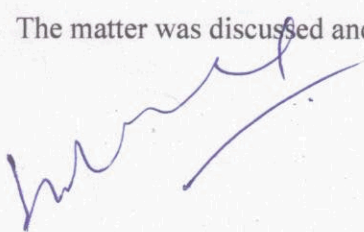

Decision: The matter was discussed and approved.

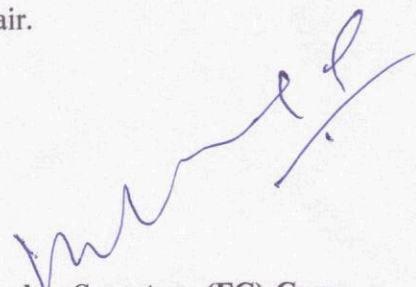


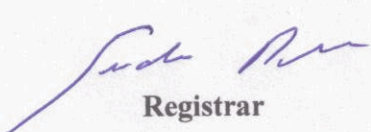
**ITEM NO. 16.2S ARREAR REGARDING PENSION/FAMILY PENSION FOR

AND AFTER 2016.**

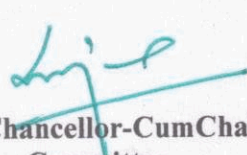
Decision: The matter was discussed and approved. Payment to be done as per Punjab Govt. notification. The arrear shall be paid after the vetting has been done for the concerned employee.

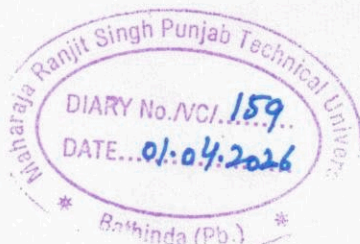

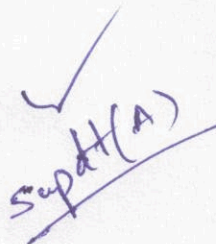
